The following action was taken by the Board of Muskingum County Commissioners at its meeting today, November 02, 2017:

A RESOLUTION TO CHANGE DESIGNATION OF A PORTION OF KOPCHAK ROAD AND FAIRVIEW ROAD, FALLS TOWNSHIP MUSKINGUM COUNTY ENGINEER

It was moved by Commissioner Crooks, seconded by Commissioner Cameron, that this Board of County Commissioners, Muskingum County, Ohio adopts the following resolution:

WHEREAS, a recommendation has been received by the Muskingum County Engineer, to change designation for the following roads in Falls Township:

- ⑦ and ⑧ \*Kopchak Road, TR 422, from US40 (West Pike) to Springfield Township Line – change designation to County Road
- ⑥ \*Fairview Road, CR309, from SR60 (Frazeyburg Road) to Dresden Road (CR2) excluding portions of the road within the City of Zanesville – change designation to Township Road

THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Muskingum County, Ohio that the above designation changes in Falls Township. The maintenance responsibility for each roadway shall be performed by the appropriate authority (township or county) accordingly.

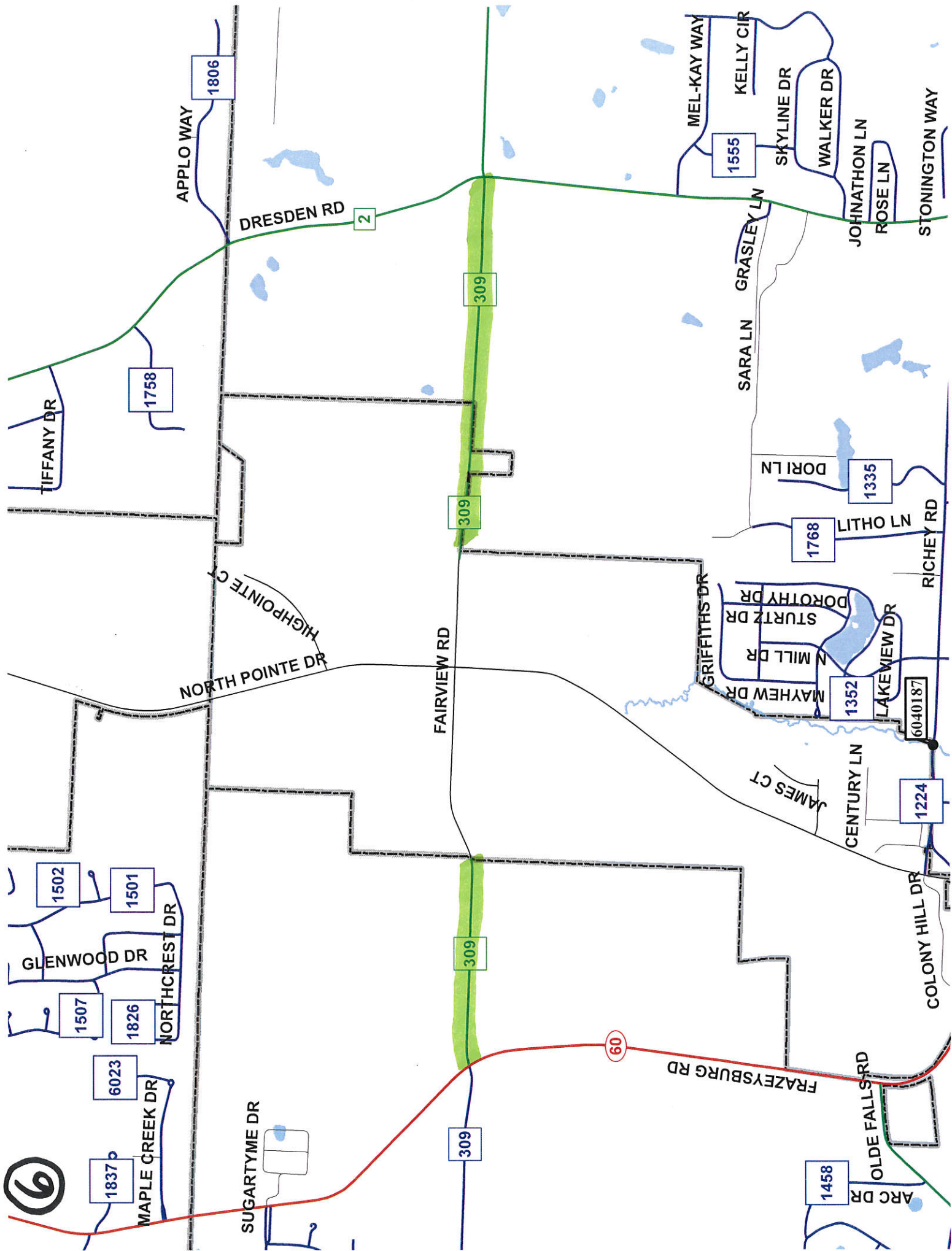

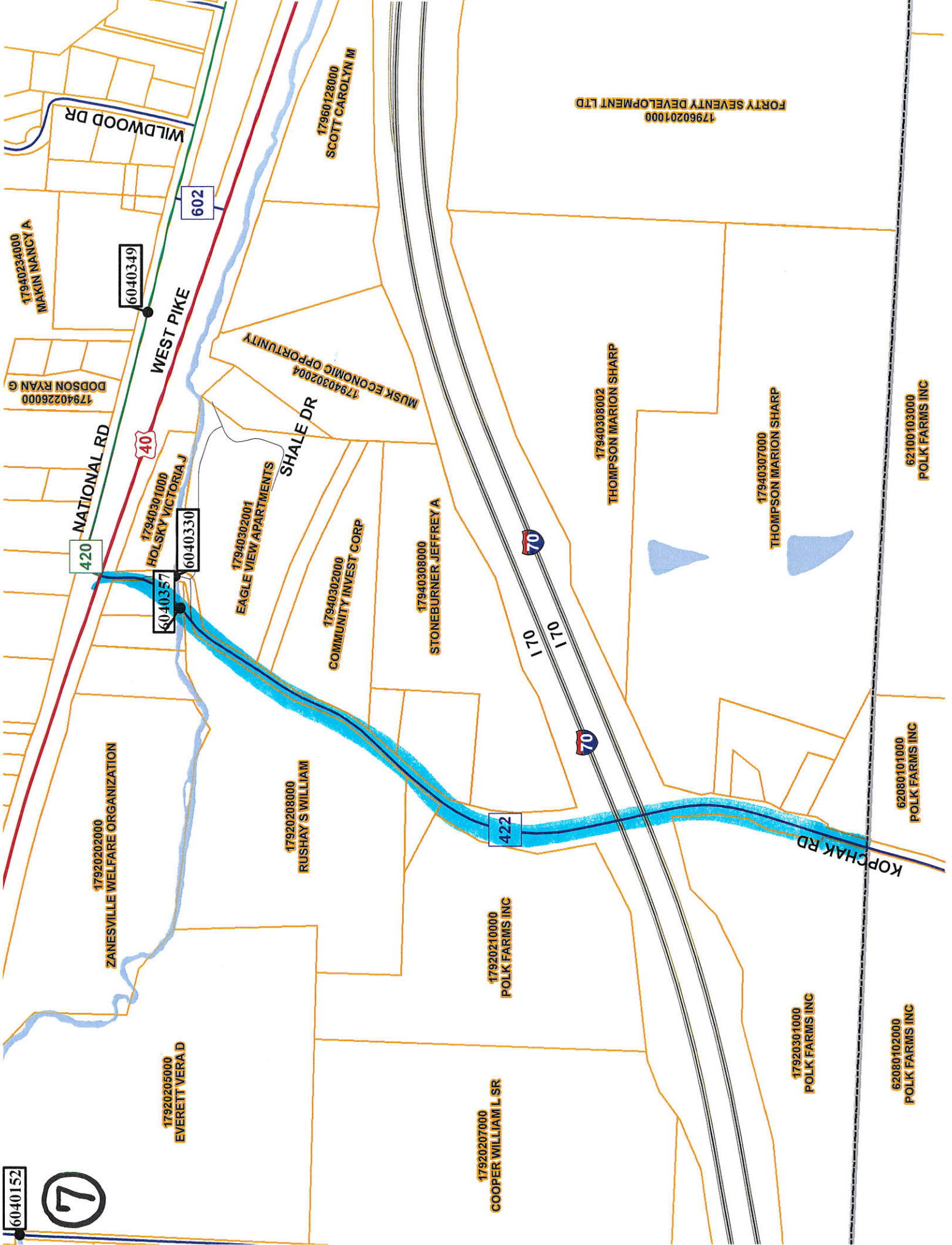
