Resolution.

*Howell moved and Cochran seconded that the following resolution be passed.
Whereas, an application has been duly presented to this board of County Commissioners for
authority and consent to annex to the incorporated village of Cannelville in this county
certain territory adjacent thereto; and whereas, it appears that said application was signed
by a majority of the adult freeholders residing on the territory sought to be attached
and that said application contained the names of a person duly authorized to act as agent
of said petitioners in securing such annexation, and that accompanying said petition was
an accurate map or plat of said territory with a full and correct description thereof,
that due notice according to statute has been given, and that no objections have been made
to said annexation;*

*Be it therefore resolved and ordered that the prayer of said Petition be granted and
that consent thereto is hereby given to annex to said Village said territory as set out and
described in said plat and that this order to be placed upon the journal and a transcript of
the proceedings relating thereto, together with said plat and petition be sent to the clerk
of said municipality.*

*At the reading of the resolution contained in the transcript received from
the commissioners of Muskingum County, Ohio, in the matter of the application for
the annexation of territory to the village of Cannelville, Ohio, it was moved and
seconded that the following resolution be passed: -*

*Whereas, on the 6th day of October, 1913, a transcript of the proceedings of
the County Commissioners of Muskingum County, Ohio, relating to the application
for the annexation of territory to the said village of Cannelville was received and duly
filed; and;*

*Whereas, it appears that more than sixty days have elapsed since the receipt
and filing of said transcript and that no objections have been made to said annex-
ation, and no notice of any proceedings to enjoin future proceedings thereunder
have been received; and*

*Whereas, it appears to this council advisable and proper that said annexation
be had and this being the next regular session after the expiration of said sixty days
from the date of the filing of said transcript,*

*Be it therefore resolved that said application for said annexation of
territory be by this council accepted and that said additional territory become a
part of this Municipal Corporation.*
