**1589.04 acres**

Situated in the State of Ohio, County of Muskingum, Township of Adams, Quarter Township Two, and being all of Lots 1, 10, and 11, and part of Lots 2, 3, 4, 8, 9, 12, and 13, and part of the West Half of Section 3, and part of the Northwest Quarter of Section 8, Township 3, Range 6, United States Military Lands, and being part of the lands presently owned by Columbus Southern Ohio Electric Company, as per Muskingum County Deed Records: DR 573-904, DR 492-264, DR 578-101, DR 513-125, DR 485-647, DR 464-284, DR 485-658, DR 448-191, DR 564-52, DR 485-664, DR 485-652, DR 485-655 and DR 564-51, and being more particularly described as follows:

Beginning for reference and the principal place of beginning, at a monument found on the Northwest Corner of the Northeast Quarter of Section 3, and being the northwest corner of lands presently owned by Muskingum Watershed Conservancy District, (DR 331-123);

Thence along the lines of said Conservancy lands the following eight courses:

- 4) South 88 degrees 16 minutes 52 seconds East, 532.96 feet to axle found, passing an iron pin found at 150.00 feet;
- 5) South 01 degrees 43 minutes 25 seconds West, 899.35 feet to an axle found;
- 6) South 88 degrees 15 minutes 09 seconds East, 539.08 feet to an axle found;
- 7) North 01 degrees 26 minutes 11 seconds East, 899.36 feet to an axle found;
- 8) South 88 degrees 14 minutes 44 seconds East, 250.06 feet to an iron pin found on the northeast corner of the Northeast Quarter of Section 8;

Thence along the east line of said Northeast Quarter of Section 8, South 01 degrees 58 minutes 27 seconds West, 2637.20 feet to an iron pin set on the southeast corner of said northeast quarter of Section 8;

Thence along the south line of said northeast quarter of Section 8, North 87 degrees 16 minutes 43 seconds West, 2677.94 feet to an iron pin set on the southwest corner of the northwest quarter of Section 8;

Thence along the west line of said northwest quarter of Section 8, North 00 degrees 13 minutes 33 seconds West, 124.26 feet to an iron pin set on the southeast corner of Lot 11;

Thence along the south line of Lot 11, North 88 degrees 18 minutes 49 seconds West, 2661.07 feet to an iron pin set on the southeast corner of Lot 12;

Thence along the south line of said Lot 12, North 89 degrees 10 minutes 41 seconds West, 1353.86 feet to a stone found on the northeast corner of lands presently owned by R. L. and C. S. Roahrig (DR 995-105);

Thence along the north line of said Roahrig land, and the south line of Lot 12, North 88 degrees 34 minutes 43 seconds West, 1297.18 feet to a stone found on the southeast corner of Lot 13;

Thence along the east line of Lot 13, and said Roahrig lands, North 01 degrees 51 minutes 06 seconds East, 223.39 feet to an iron pin found;

Thence along the north line of said Roahrig lands, North 87 degrees 35 minutes 48 seconds West, 1341.35 feet to an iron pin found on the west line of the east half of Lot 13, and the east line of lands presently owned by the State of Ohio, Department of Natural Resources (DR 1130-775) (Tri-Valley Wildlife Area);

Thence along said west line, North 01 degrees 59 minutes 23 seconds East, 153.05 feet to a stone

found on the southwest corner of lands presently owned by R. F. and D. J. Hogue (OR 2226-458);

Thence along said Hogue lands the following four courses:

- 1) North 54 degrees 12 minutes 27 seconds East, 783.58 feet to an iron pin set on the south side of Stone Church Road;

Thence along the east line of said State of Ohio lands, North 01 degrees 52 minutes 30 seconds East, 660.00 feet to a monument found on the southeast corner of lands presently owned by L. G. Emerson (OR 1518-351);

Thence along said Emerson lands the following six courses:

- 2) South 89 degrees 59 minutes 30 seconds East, 618.92 feet to an iron pin set;

Dawson (DR 1064-641);

Thence along the west line of Lot 4, and the east line of said Dawson lands, North 01 degrees 43 minutes 15 seconds East, 1251.33 feet to a pipe found on the southwest corner of lands presently owned by G. Heather and C. R. Yoho (DR 782-269);

Thence along the lines of said Heather and Yoho lands the following two courses:

- 1) South 88 degrees 34 minutes 34 seconds East, 1341.21 feet to a pipe found;
- 2) North 02 degrees 00 minutes 46 seconds East, 1304.59 feet to a pipe found on the Muskingum/Coshocton County Line, and the south line of lands presently owned by P. C. and D. Tumblin (DR 673-209);

Thence along the county line, South 89 degrees 42 minutes 59 seconds East, 255.24 feet to a point on the mean high water line of the south bank of Wills Creek;

Thence continuing along said county line, South 88 degrees 17 minutes 56 seconds East, 35.22 feet a point on the southwest corner of Fractional Section 23;

Thence along the north line of said section 3, South 86 degrees 16 minutes 05 seconds East, 1353.13 feet to the principal place of beginning, containing 1592.98 acres, more or less.

- 5) Along the centerline of said road, North 44 degrees 56 minutes 31 seconds East, 33.06 feet to a point;
- 6) South 01 degrees 37 minutes 47 seconds West 447.76 feet to an iron pipe found, passing a pipe found at 32.75 feet, and the lot line at 437.76 feet;
- 7) North 88 degrees 18 minutes 48 seconds West, 548.46 feet to an iron pin set;
- 8) North 01 degrees 44 minutes 05 seconds East, 10.00 feet to the principal place of beginning, containing 3.94 acres, more or less;

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars, 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, North Zone, Grid North, as per GPS observations.

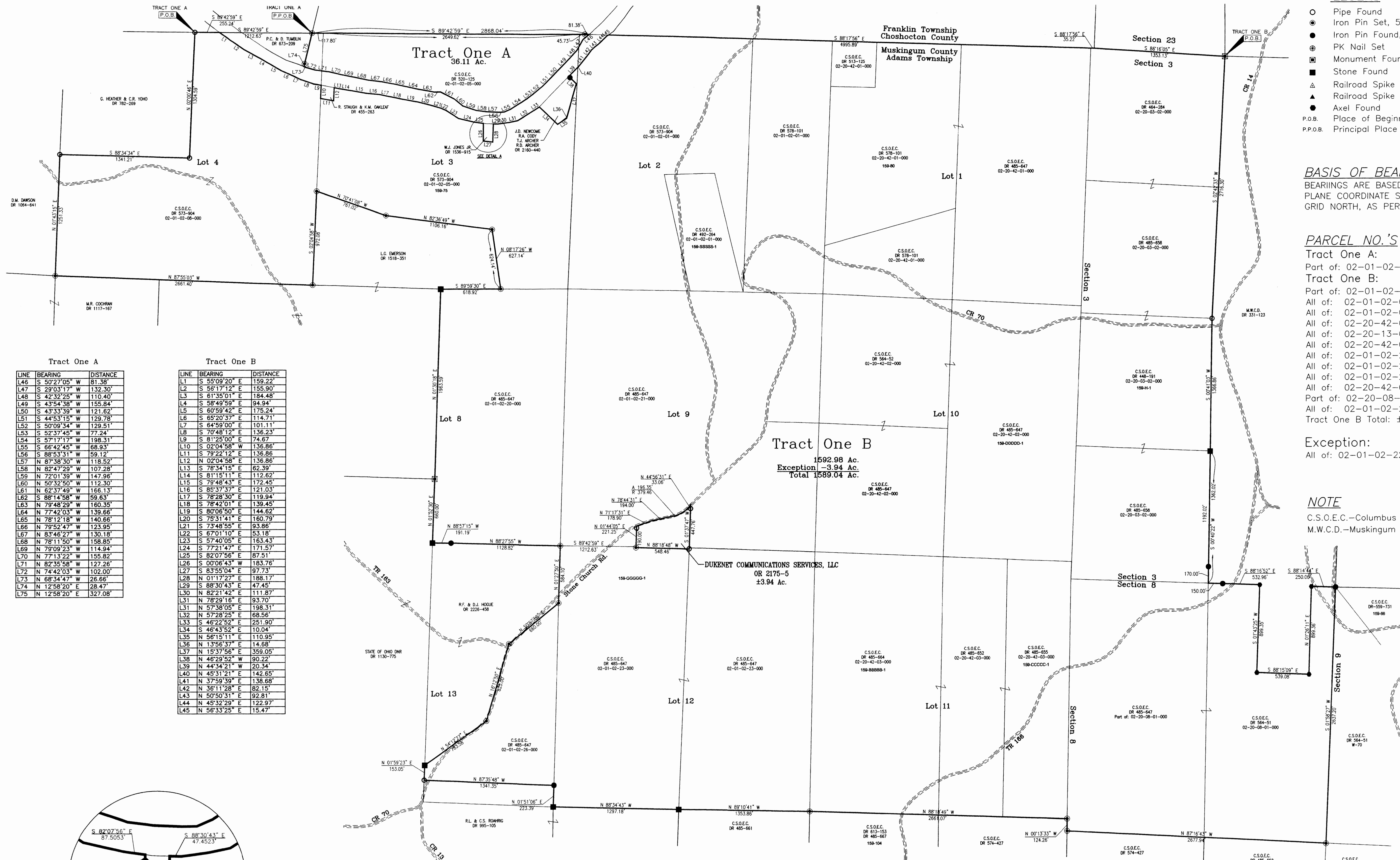

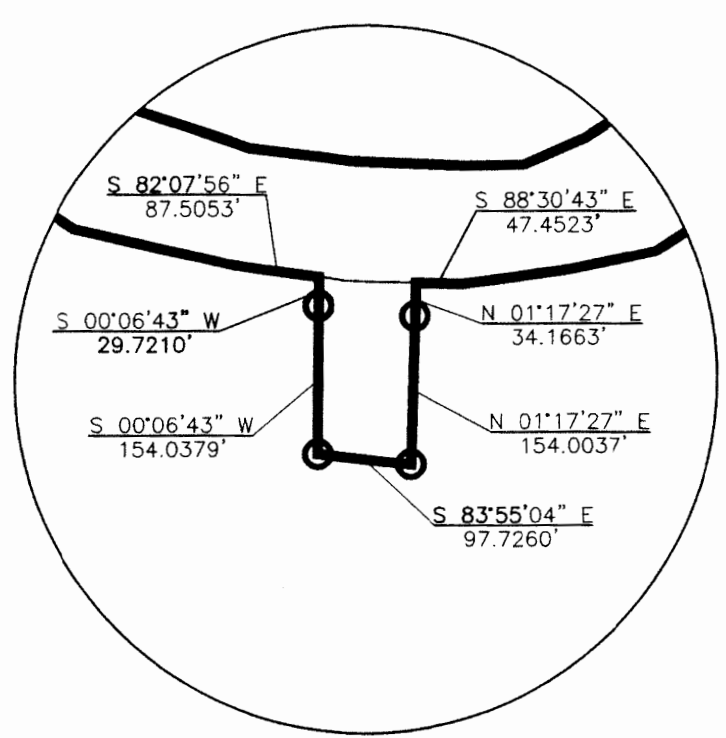

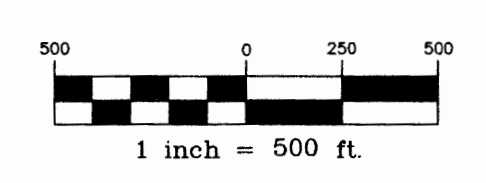
