LEGAL DESCRIPTION Tract Seven

Situated in the State of Ohio, County of Muskingum, Township of Adams and being part of the northeast and northwest quarters of Section 11, and part of the southwest quarter of Section 10, Township 3, Range 6 of the United States Military Lands, and being part of those lands intended to be described in Deed Volume 1994, page 409; being further bounded and described as follows:

Beginning at an iron pin set at the southwest corner of the northwest quarter of the northeast quarter of Section 11, thence, north 88 degrees – 13 minutes – 05 seconds west, 1323.39 feet, along the north line of those lands now or formerly owned by J. & L. Shetler (1128/387) and R. & T. Shoup (1643/497), to a corner post found;

Thence, north 32 degrees – 16 minutes – 11 seconds east, 1678.00 feet along the southeasterly line of those lands now or formerly owned by Columbus and Southern Ohio Electric Company (599/109) to an iron pin set;

Thence, south 35 degrees – 39 minutes – 09 seconds east, 1827.42 feet, with the new division line through the lands now or formerly owned by A. Hostetler (1994/409) to an iron pin set;
