Beginning at the southwest corner of the east half of the southeast quarter of said section 13; thence north 08 degrees 06 minutes 06 seconds east along the half section line a distance of 651.75 feet to a post; thence south 81 degrees 50 minutes 52 seconds east a distance of 325.71 feet to a point in Big Run Lane; thence south 14 degrees 24 minutes east along said lane a distance of 60.00 feet to a spike; thence south 02 degrees 57 minutes east along said lane a distance of 80.00 feet to a spike; thence south 26 degrees 58 minutes west along said lane a distance of 100.00 feet to a spike; thence south 16 degrees 28 minutes west along said lane a distance of 145.00 feet to a spike; thence south 29 degrees 26 minutes east along said lane a distance of 390.00 feet to a spike; thence south 14 degrees 11 minutes east along said lane a distance of 100.00 feet to a spike; thence south 04 degrees 29 minutes west along said lane a distance of 100.00 feet to a spike in Edgemoore Road; thence north 58 degrees 21 minutes west along said road a distance of 170.00 feet to a spike; thence north 52 degrees 47 minutes west along said road a distance of 200.00 feet to a spike; thence north 63 degrees 05 minutes west along said road a distance of 100.00 feet to a spike; thence north 73 degrees 30 minutes west along said road a distance of 169.00 feet to the place of beginning containing Six and Seventy (6.70) hundredths acres more or less. 2.00 acres in section 18 and 4.70 acres in section 13.

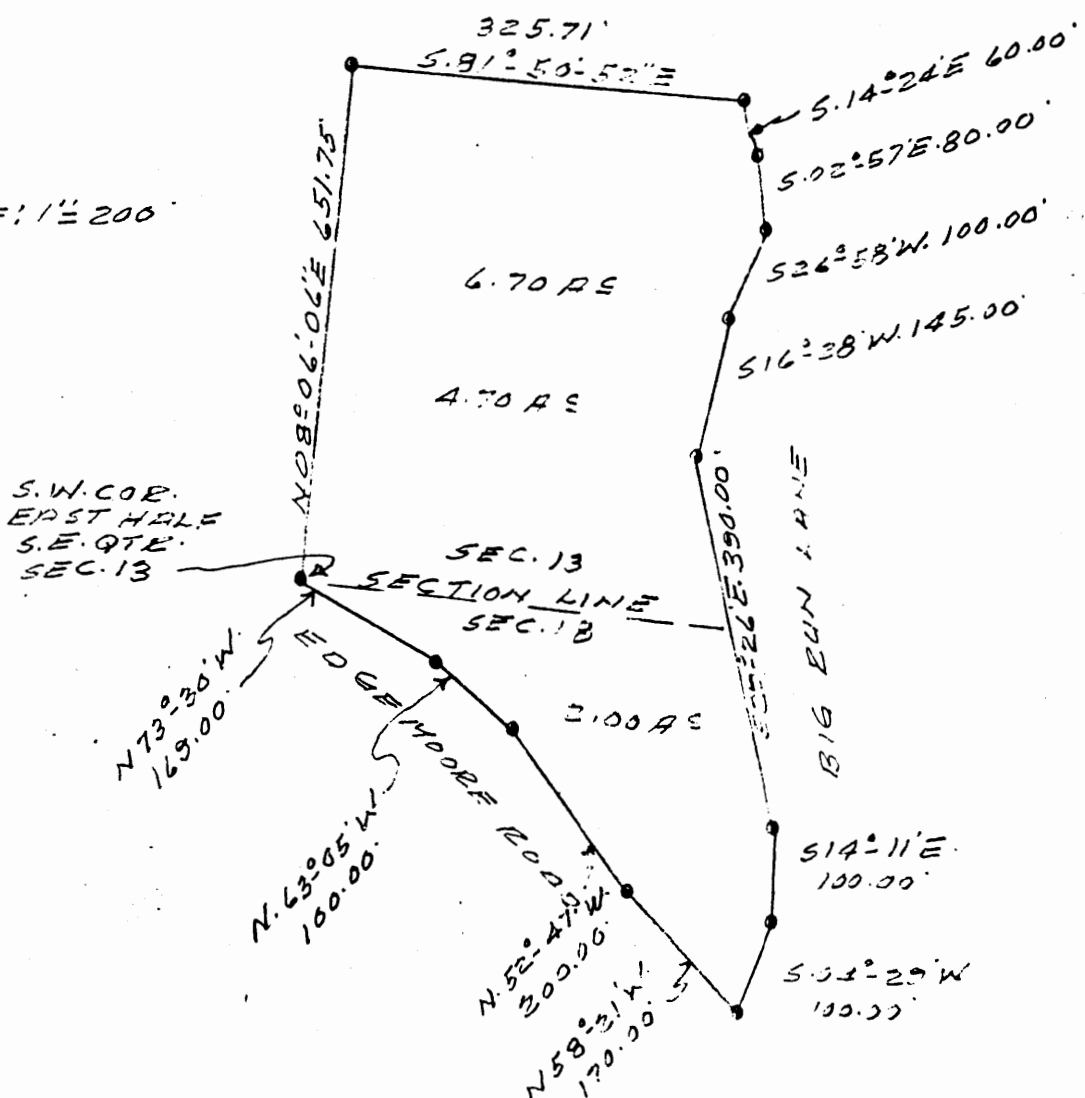
