

Situated in the State of Ohio, County of Muskingum, Township of Blue Rock:

Being part of the Southeast Quarter, of Section #10, Township #12, Range #12, of the Congress Lands East of the Scioto River, **being all of** the Lois Kilpatrick and Doii Berget property described in Tract 1 the Third and Fourth Parcels, all of Tract 2, all of Tract 3 the First Parcel, and all of Tract 4, of deed reference Deed Book Volume 683, Page 130 of said county's deed records, known as Muskingum County **Auditor's Parcel Number 06-10-10-07-000**, and more particularly described as follows;

Beginning at an iron pin (set) at the Southeast corner of Section #10, also being the common corner for Sections #11, #14, & #15 of said township and range;

- #1- **thence N 87 42 20 W 2603.43 feet** along the common line for said Sections #10 & #15 to a concrete monument (found) at the Southwest corner of said Southeast Quarter, passing iron pins (set) at 1007.72 feet and 1380.33 feet;
- #2- **thence N 03 20 35 E 1933.56 feet** along the common line for the Southwest and Southeast Quarters of Section #10 to an iron pin (set) at the Southwest corner of the R & J Shook property recorded in deed reference Deed Book Volume 1130, Page 717, also being a common corner for Lots #4 & #5 of a survey of the Southeast Quarter of Section #10 by Lewyllen Scarvell completed prior to April 1872;
- #3- **thence S 87 32 10 E 172.91 feet** into said Southeast Quarter and along the common line for said Lots #4 & #5 and South line of said Shook property to the center of Cutler Lake Road (County Road #45), passing an iron pin (set) at 137.04 feet;
- #4- **thence N 21 44 10 W 192.61 feet** through said Lot #5, along the center line of said road and East line of said Shook property to an unmarked point;
- #5- **thence along a curve to the right have a chord bearing of N 15 12 00 W 181.31 feet**, a radius of 804.50 feet and arc length of 181.69 feet continuing through said Lot #5 and along said road and East line of said Shook property to the Northeast corner of said Shook property, also being on the common line for Lots #5 & #6 of said Scarvell survey;
- #6- **thence N 87 32 10 W 33.59 feet** leaving said road and along the common line for said Lots #5 & #6 to an iron pin (set) at a common corner for said Lots #5 & #6, also being the Northwest corner of said Shook property, and on the common line for the Southeast and Southwest Quarters of Section #10;
- #7- **thence N 03 20 40 E 348.48 feet** along the common line for said Southwest and Southeast Quarters of Section #10 to a concrete monument (found) at the center of Section #10;
- #8- **thence S 87 32 15 E 2574.60 feet** along the common line for the Southeast and Northeast Quarters of Section #10 to a concrete monument (found) at the Northeast corner of said Southeast Quarter of Section #10;
- #9- **thence S 02 43 00 W 2622.62 feet** along the common line for Sections #10 & #11 to the place of beginning, **containing 155.33 acres.**

The bearings within this description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).





