Situated in the State of Ohio, County of Muskingum, Township of Blue Rock, T 12, R 12, part of Section 33 and Southeast Quarter of Section 32 and bounded and described as follows:

First Parcel:

Being the Southwest Quarter of Section 28, Township 12, Range 12, containing 159 acres more or less. All of Auditor's Parcel No. 06-06-80-28-37-000.

Second Parcel:

Being the Northwest Quarter of Section 33, Township 12, Range 12, containing 159.13 acres more or less, containing all of Auditor's Parcel Numbers 06-06-80-33-02-000, 06-06-80-33-03-000 and 06-06-80-33-04-000.

Third Parcel:

Commencing at the Northeast corner of the Southwest Quarter of Section 33; thence on section line North $87^{\circ} 03' 43''$ West 1321.65 feet to an iron pin set, the place of beginning; thence along section line North $87^{\circ} 03' 43''$ West 1408.44 feet to an iron pin set passing the Northwest corner of Southwest Quarter of Section 33 at 1309.44 feet; thence South $49^{\circ} 46' 17''$ West 198.00 feet to an iron pin set; thence South $8^{\circ} 33' 43''$ East 429.00 feet to an iron pin set; thence South $15^{\circ} 30'$ West 577.50 feet to an iron pin set; thence South $39^{\circ} 33' 43''$ East 148.50 feet to an iron pin set; thence North $76^{\circ} 56' 17''$ East 168.30 feet; thence South $87^{\circ} 03' 43''$ East 363.00 feet; thence North $83^{\circ} 51' 17''$ East 478.50 feet; thence North $53^{\circ} 26' 17''$ East 112.20 feet; thence North $73^{\circ} 45' 54''$ East 432.76 feet to the East line of said section; thence North $2^{\circ} 56' 17''$ East 893.58 feet to the place of beginning passing an iron pin set at 45.00 feet, containing 38.68 acres more or less. Being 33.17 acres in Section 33 and 5.51 acres in Section 32.

Bearings are based on the North line of the Southwest Quarter of Section 33 bearing North $87^{\circ} 03' 43''$ West.

Being all of Auditor's Parcel Numbers 06-06-80-33-05-000, 06-06-80-33-06-000 and 06-06-70-32-13-001.
