

Situated in the State of Ohio, County of Muskingum, Township of Blue Rock, and being part of the southeast and southwest quarters of Section 26, Township 12, Range 12, and being part of those lands intended to be described in Deed Volume 427, page 491 and Deed Volume 995, page 289; being further bounded and described as follows:

Commencing at the northeast corner of the northwest quarter of said Section 26, thence, South 06 degrees -20 minutes -26 seconds West, 2638.01 feet along the midsection line to the true point of beginning for the parcel herein intended to be described;

Thence, South 82 degrees - 36 minutes - 21 seconds East, 2580.44 feet to a point in County Road #31 (Rural Dale Road), from which an iron pin found bears South 07 degrees – 08 minutes – 51 seconds West, 25.00 feet;

Thence, along said road, the following seventeen (17) courses and distances:

1. North 83 degrees – 08 minutes – 06 seconds West, 464.77 feet to a point; 2. South 85 degrees -37 minutes -00 seconds West, 69.20 feet to a point; 3. South 68 degrees – 42 minutes – 58 seconds West, 63.54 feet to a point; 4. South 59 degrees – 49 minutes – 36 seconds West, 130.11 feet to a point; 5. South 76 degrees – 45 minutes – 46 seconds West, 61.40 feet to a point; 6. North 86 degrees – 52 minutes – 33 seconds West, 65.02 feet to a point; 7. North 77 degrees -20 minutes -22 seconds West, 237.72 feet to a point; 8. North 85 degrees – 59 minutes – 59 seconds West, 86.58 feet to a point; 9. South 84 degrees – 21 minutes – 29 seconds West, 281.35 feet to a point; 10.South 79 degrees – 43 minutes – 58 seconds West, 168.90 feet to a point; 11.South 64 degrees – 20 minutes – 07 seconds West, 64.07 feet to a point; 12. South 52 degrees – 27 minutes – 36 seconds West, 114.00 feet to a point; 13.South 63 degrees – 58 minutes – 52 seconds West, 68.56 feet to a point; 14.South 77 degrees – 20 minutes – 38 seconds West, 82.15 feet to a point; 15.South 84 degrees – 30 minutes – 03 seconds West, 86.85 feet to a point; 16.North 87 degrees – 50 minutes – 31 seconds West, 126.09 feet to a point; 17.North 87 degrees – 12 minutes – 59 seconds West, 224.62 feet to a point;

Thence, leaving said road, North 01 degrees -02 minutes -34 seconds East, 236.76 feet to an iron pin set, passing an iron pin set at 20.00 feet;

Thence, North 89 degrees – 02 minutes – 28 seconds West, 616.88 feet to an iron pin set;

Thence, North 05 degrees - 40 minutes - 58 seconds East, 317.02 feet to an iron pin set;

Thence, South 82 degrees - 36 minutes - 21 seconds East, 342.98 feet to the point of beginning, and containing 14.7037 acres more or less.


SUBJECT to all legal highways and easements of record, whether recorded or implied.
