- TIE-1 THENCE North 35 degrees 12 minutes 30 seconds East 289.32 feet** crossing the James & Delores Webb proeprty recorded in Deed Book Volume 1134, Page 80 and cross the abandoned right of way for the B & O Railroad to an iron pin (found) on the Northeast right of way for said railroad and common corner for said Morrison property and for the Dennis Wilson property recorded in Deed Book Volume 1131, Page 286;
- TIE-2 THENCE North 38 degrees 51 minutes 45 seconds East 302.21 feet** along the common line for said Morrison and Wilson properties to the Low Water Mark of the Muskingum River, passing the centerline of Old River Road (County Road #6A) at 248.21 feet, and iron pin (found) at 260.21 feet;
- TIE-3 THENCE North 52 degrees 15 minutes 00 seconds West 52.23 feet** along said low water mark up flowage to the place of beginning for the property herein intended to be described;
