Situated in the State of Ohio, County of Muskingum, Township of Brush Creek,
Township 11, Range 13, Section 8, bounded and described as follows:

Being part of Earl Winn Deed Vol. 1063, Page 134, Parcel Number 08-08-07-08-02-000.

Commencing at an axle found at the ~~SW~~ **SE** ~~Cor.~~ **Qtr.** of Section 8; Thence South 89°21'06" East 1304.65 feet to a concrete monument found; Thence North 4°52'00" East 158.35 feet to a point; Thence North 11°40'00" East 464.77 feet to a point at the low water edge of the Muskingum River passing an axle at 432.77 feet; Thence along the Muskingum River North 72°15'00" West 830.70 feet to a point; Thence North 68°36'32" West 491.22 feet to a point the place of beginning; Thence South 21°30'55" West 231.37 feet to a point passing an iron pin set at 30.05 feet and center of County Road 6 at the intersection of Sealover Hollow Road center line at 45.05 feet; Thence continuing along center of Sealover Hollow Road the next 3 courses and distances: South 26°54'01" West 152.81 feet to a point, South 26°23'51" West 72.03 feet to a point, and South 20°09'48" West 57.15 feet to a point on Old B&O Railroad Right of Way; Thence along said right of way North 60°20'29" West 58.58 feet; Thence North 59°45'00" West 866.71 feet to an axle found; Thence along C. Fink Vol. 1144, Page 949 the next three courses and distances: North 20°00'00" East 100.00 feet to an axle found; Thence North 5°00'00" West 235.00 feet to the center of County Road 6 passing an axle found at 229.00 feet; Thence leaving said road North 20°00'00" East 60.00 feet to the low water line Muskingum River; Thence along the Muskingum River South 68°36'32" East 1042.92 feet to the place of beginning containing 9.84 acres more or less:

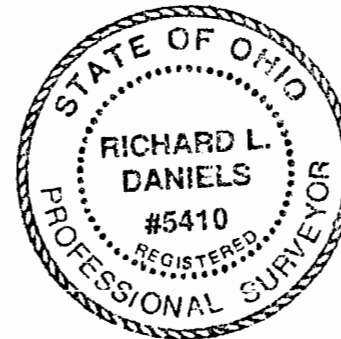
Iron pins set are No. 5 reinforced bars 30 inches long with plastic ID caps.

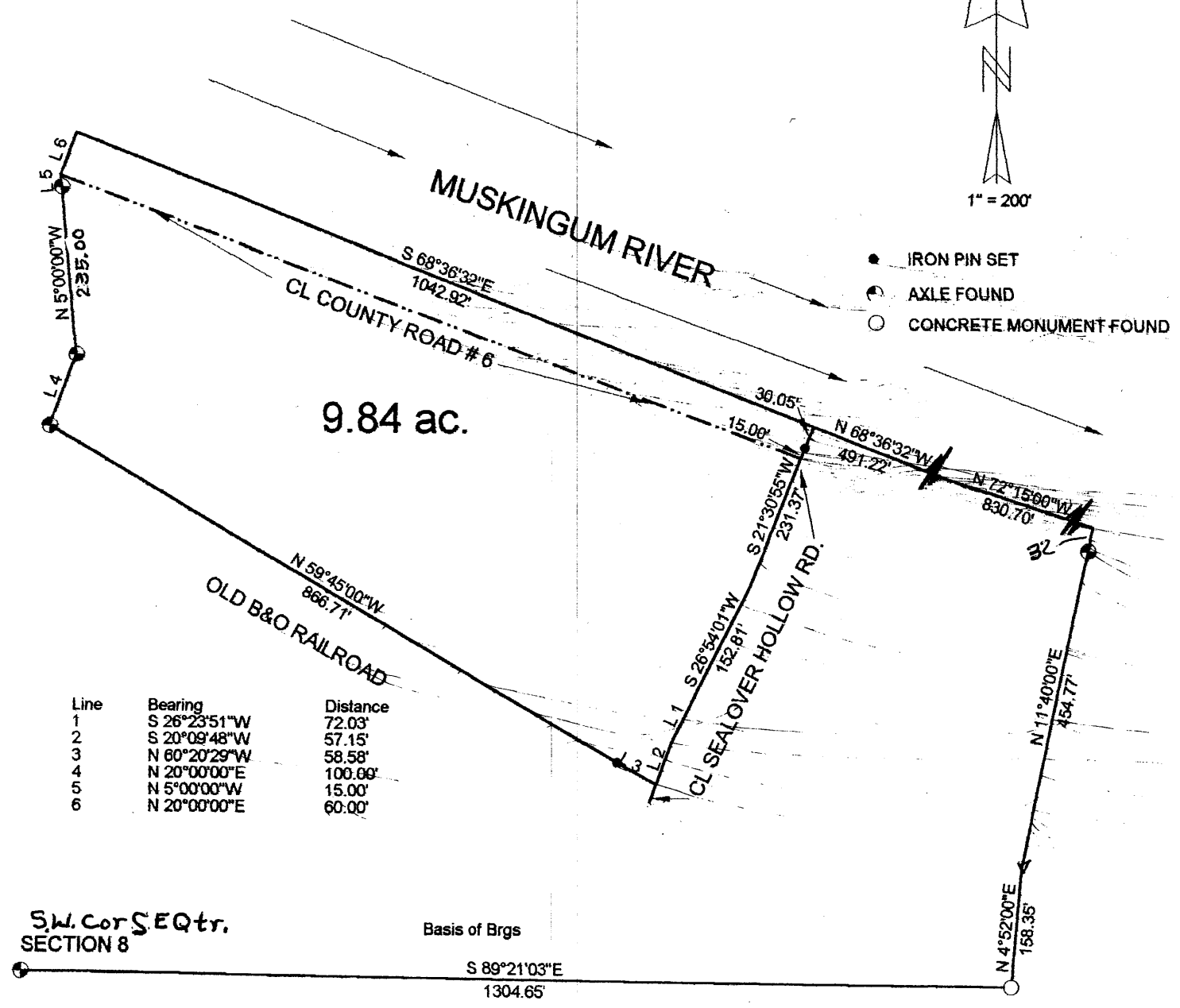

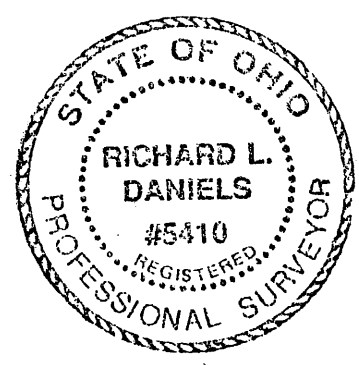
