**LEGAL DESCRIPTION FOR TRI SCOURCE TITLE  
1.436 ACRES**

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, and being a part of the Northeast Quarter of Section 17, Township 11, Range 13, in the Congress Lands East of the Scioto River, and being all of a 0.84 Acre Parcel, Parcel 2 as conveyed to John M. & Mary L. Vaughn by deed of record in Deed Volume 1076, Page 572, parcel number 082011701000, all references being to those of record in the Recorder's Office in Muskingum County, Ohio. The 1.436 Acre parcel being more particularly bounded and described as follows.

Beginning at an iron pin found with cap #6456, marking the northeast corner of Section 17 and also being the northwest corner of a parcel as conveyed to Hague Water Conditioning by deed of record in Deed Volume 1861, Page 574, and also being the southwest corner of a 2.0 Acre parcel as conveyed to Charles F. Kimes by deed of record in Deed Volume 947, Page 164.

Thence **South 59°00'34" West, 293.91 Feet** along an old existing farm lane to the centerline of Flattler Ridge Road (Twp. Rd. 85), and also the northerly line of a 12.559 Acre parcel as conveyed to William E. & Karen L. Leslie by deed of record in Deed Volume 1131, Page 972, passing an iron pin set at 227.69 Feet.

Thence northwesterly along the centerline of Flattler Ridge Road (Twp. Rd. 85) and along the northerly line of the said 12.559 Acre Leslie parcel the following five courses and distances.

**North 53°22'06" West, 45.85 Feet** to a point.

**North 61°32'24" West, 79.12 Feet** to a point.

**North 63°31'27" West, 271.59 Feet** to a point.

**North 67°30'02" West, 141.37 Feet** to a point.

**North 71°04'02" West, 5.28 Feet** to a point on the northerly line of Section 17, and the southerly line of a 19.82 Acre parcel as conveyed to Muskingum Metal & Iron by deed of record in Deed Volume 501, Page 289.

Thence **South 82°59'26" East, 742.57 Feet** along the northerly line of Section 17, and the southerly line of the said 19.82 Acre Muskingum Metal and Iron parcel and the southerly line of a 1.181 Acre parcel as conveyed to John M. & Mary L. Vaughn, parcel 1, by deed of record in Deed Volume 1076, Page 572, to the **Point of Beginning** and containing **1.436 Acres** more or less according to a survey made by Blaine Surveying Ltd., during July and August of 2007.

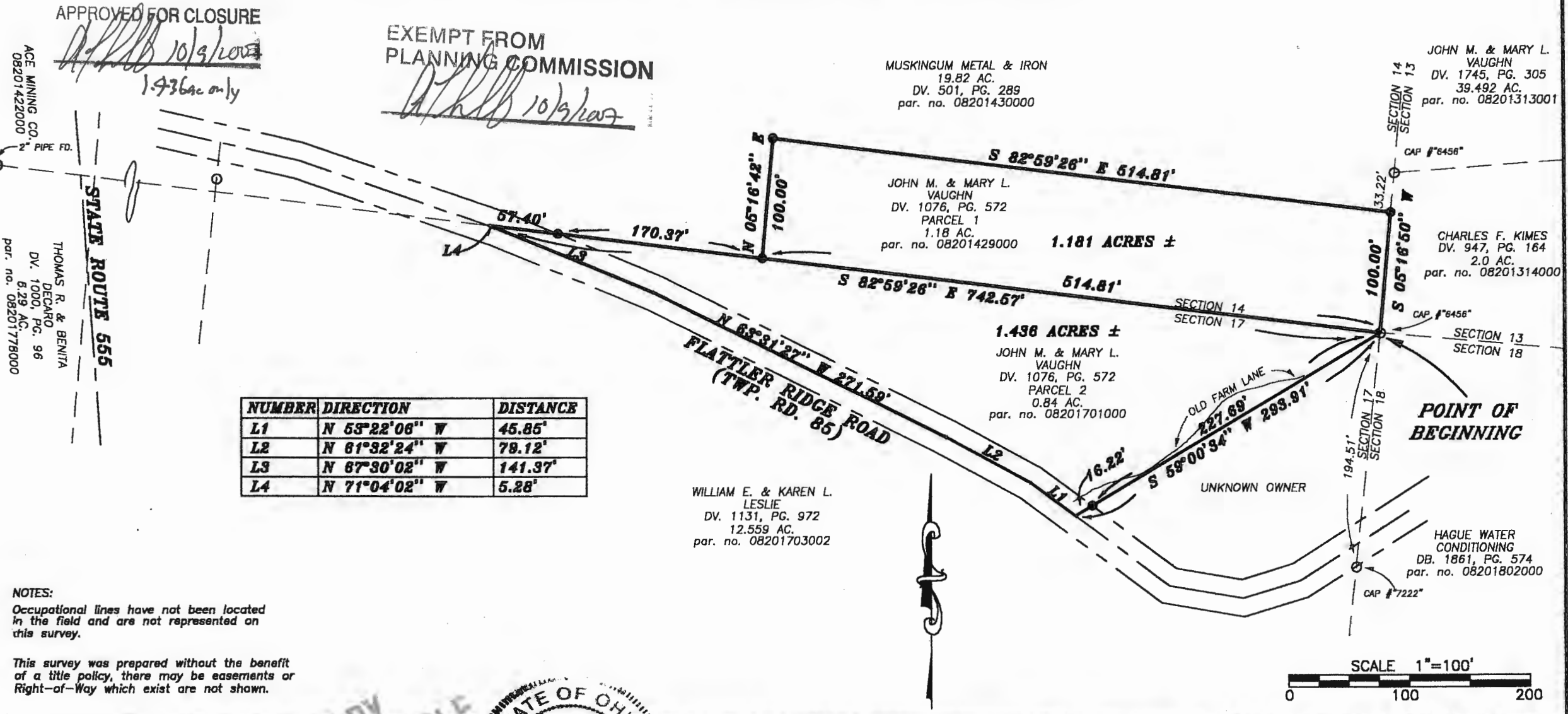
