DESCRIPTION OF SURVEY FOR WILSON/DEITRICK/DALTON JOB#1255-1

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek:


Being part of Northeast and Northwest Quarters of Section #26, Township #11, Range #13, of the Congress Lands East of the Scioto River, **being all of** the Kay Wilson, Robert Deitrick, an Anna Dalton property recorded in Deed Book Volume 1056, Page 437 of said county's deed records, located in said Section #26, known as Muskingum County **Auditor's Parcel Numbers 08-30-26-02-000 and 08-30-26-04-000**, and more particularly described as follows;

Beginning at an iron pipe (found) at the common corner for Sections #24, & #25, #26, & #27 of said Township and Range;

- #1- THENCE South 03 degrees 33 minutes 40 seconds West 2213.34 feet along the common line for Sections #26 & #27 to an iron pin (set) at the Northeast corner of the R Mumaw property recorded in Official Record Volume 1651, Page 812;
- **#2- THENCE South 81 degrees 42 minutes 40 seconds West 594.00 feet** into said Section #26 and along the North line of said Mumaw property to an iron pin (set) at the Northwest corner of said Mumaw property;
- **#3- THENCE South 21 degrees 40 minutes 35 seconds East 396.00 feet** along the West line of said Mumaw property to an iron pin (set) on the common line for the Northeast and Southeast Quarters of Section #26;
- **#4- THENCE North 86 degrees 40 minutes 20 seconds West 2220.63 feet** along said common line for the Northeast and Southeast Quarters of Section #26 to an iron pin (found) at the center of Section #26;
- #5- THENCE North 86 degrees 25 minutes 20 seconds West 168.00 feet along the common line for the Northwest and Southwest Quarters of Section #26 to an iron pin (set) at the Southwest corner of Parcel Two of Tract One of said prior deed reference;
- #6- THENCE North 04 degrees 18 minutes 40 seconds East 448.00 feet into the Northwest Quarter of Section #26 and along the West line of said Parcel Two to an unmarked point in a Strip Mine Impoundment, passing an iron pin (set) at 394.15 feet;
- #7- THENCE North 75 degrees 25 minutes 40 seconds East 167.00 feet along the North line of said Parcel Two to an iron pin (set) at the Northeast corner of said Parcel Two, being on the common line for the Northwest and Northeast Quarters of Section #26;
- **#8- THENCE North 03 degrees 10 minutes 05 seconds East 2218.60 feet** along the common line for the Northeast and Northwest Quarters of Section #26 to an iron pin (set replacing a stone found broken at a fence corner) being the common corner for the Northeast and Northwest Quarters of Section #26 and Southeast and Southwest Quarters of Section #26;
- #6- THENCE South 86 degrees 05 minutes 40 seconds East 2651.81 feet along the common line for Sections #25 & #26 to the place of beginning, containing 1.78 acres from the Northwest Quarter and 159.21 acres from the Northeast Quarter, excepting the Merlyn F Wolfe property recorded in Deed Book Volume 1046, Page 237, by survey being 2.08 acres, for a remainder total of 158.91 acres.

The bearings within this description are based on State Plane Coordinate Grid derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
