Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, Township 11, Range 13, Websters Second Addition to Cannelville, bounded and described as follows: *Section 27*

Being all of Deed Volume 1157, page 254, Parcel Nos. 08-08-36-02-17-000 and 08-08-36-02-18, being all of Lot 56, Par. 18, and 0.094 Acres out of Lot Par. 17.

Commencing at an iron pin set at the Southwest corner of Lot 56 of Websters Second Addition to Cannelville from which the North line of Main Street bears South 21°35'28" East 255.00 feet; Thence North 21°35'28" West along Barr Drive (40 feet wide) 100.00 feet to an iron pin set at the North west corner of Lot 56 and the intersection of a 20-foot wide alley; Thence North 82°26'42" East along said alley 41.23 feet to an iron pin set at the Northeast corner of Lot 56; Thence South 77°54'04" East 72.11 feet to an iron pin set; Thence South 21°35'28" East 50.00 feet to an iron pin set on the North line of Back Street; Thence South 68°24'32" West along Back Street 100.00 feet to the place of beginning containing 0.182 Acres more or less/ 0.088 Acres in Lot 56.

Bearings are based on Barr Drive bearing North 21°35'28" West.

Iron pins set are No. 5 reinforced bars, 30 inches long, with plastic ID caps.






Basis of Bearings




Plat of Survey
