Beginning for reference at a PK nail found, at the northwest corner of Section 7, Township 3, Range 8, United States Military Lands;

Thence along the North line of Section 7, South 88 degrees 07 minutes 28 seconds East, 2135.78 feet to a point in the centerline of School House Road, and the principal place of beginning, from which an iron pin found bears South 88 degrees 07 minutes 28 seconds East, 16.97 feet;

Thence along the centerline of said road the following four courses:

- 1.) Along a non-tangent curve to the left having a delta angle of 55 degrees 20 minutes 05 seconds, a radius of 193.12 feet, an arc length of 184.39 feet, and a chord which bears North 62 degrees 25 minutes 42 seconds West, 179.35 feet to a point;

- 2.) South 30 degrees 16 minutes 00 seconds East, 20.00 feet to a monument found;
- 3.) Along a curve to the right with a delta angle of 13 degrees 00 minutes 18 seconds, a radius of 2774.93 feet, an arc length of 629.81 feet, and a chord which bears North 66 degrees 16 minutes 29 seconds East, 628.50 feet to a monument found;
- 4.) North 17 degrees 16 minutes 35 seconds West, 50.00 feet to an iron pin set;
- 5.) Along a curve to the right with a delta angle of 7 degrees 05 minutes 27 seconds, a radius of 2824.93 feet, an arc length of 349.59 feet, and a chord which bears North 76 degrees 19 minutes 54 seconds East, 349.39 feet to an iron pin set;

Thence leaving said right of way line, and along the south side of Raider's Road, North 85 degrees 06 minutes 29 seconds East, 2607.00 feet to an iron pin set on the northwest corner of lands presently owned by William L. Whyde Jr.(OR 2166-35);

Thence along the centerline of said road the following four courses:




