

+- 4.37 Acre Adjoiner Split from Longaberger to Sidwell

Situated in the State of Ohio, County of Muskingum, Township of Cass, and being part of the Southwest Quarter of Section 4, the Southeast Quarter of Section 5, and the Northwest Quarter of Section 7, Township 3, Range 8, United States Military Lands, and being part of the lands presently owned by "The Longaberger Company", as per Deed Record 1081, Page 636, and Deed Record 1108, Page 295, and being more particularly described as follows:

Beginning for reference at a PK nail found at the southeast corner of Section 5, Township 3, Range 8, United States Military Lands;

Thence along the section line, North 00 degrees 27 minutes 47 seconds East, 11.89 feet to a point, and the principal place of beginning;

Thence through the lands presently owned by "The Longaberger Company", (DR 1081-636), North 82 degrees 00 minutes 51 seconds West, 221.13 feet to an iron pin set on the south right of way of State Route 16;

Thence along the south line of said right of way, the following two courses:

- 1.) North 60 degrees 37 minutes 38 seconds East, 460.05 feet to a pipe found;
- 2.) North 68 degrees 20 minutes 55 seconds East, 419.44 feet to a pipe found on the northwest corner of lands presently owned by J. S. and S. Y. Sidwell, (OR 1158-653);

Thence along the west line of said Sidwell lands, the west line of other lands owned by said Sidwell per DR 612-144, and the west line of lands presently owned by C. L. Fitzgerald, (OR 1996-386), South 15 degrees 19 minutes 21 seconds East, 307.23 feet to an iron pin found;

Thence through said Longaberger lands the following five courses:

- 1.) South 75 degrees 54 minutes 36 seconds West, 94.06 feet to an iron pin set;
- 2.) South 70 degrees 43 minutes 14 seconds West, 365.37 feet to an iron pin set;
- 3.) South 87 degrees 53 minutes 31 seconds West, 145.80 feet to an iron pin set;
- 4.) North 01 degrees 12 minutes 03 seconds East, 24.03 feet to a PK nail set in pavement;
- 5.) North 82 degrees 00 minutes 51 seconds West, 72.35 feet to the principal place of beginning, containing 4.37 acres more or less, being 3.92 acres in Section 4, 0.39 acres in Section 5, and 0.06 acres in Section 7;

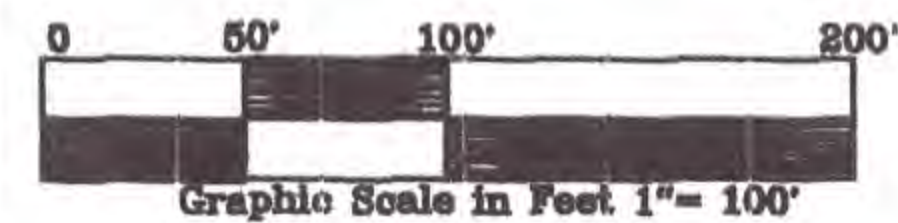
