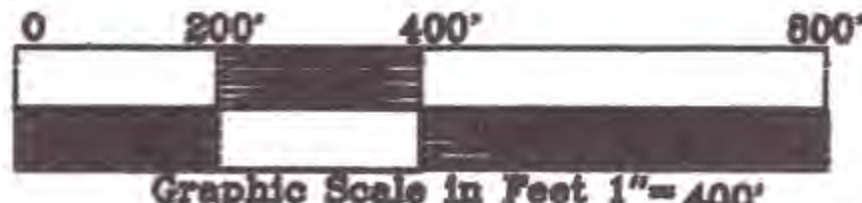
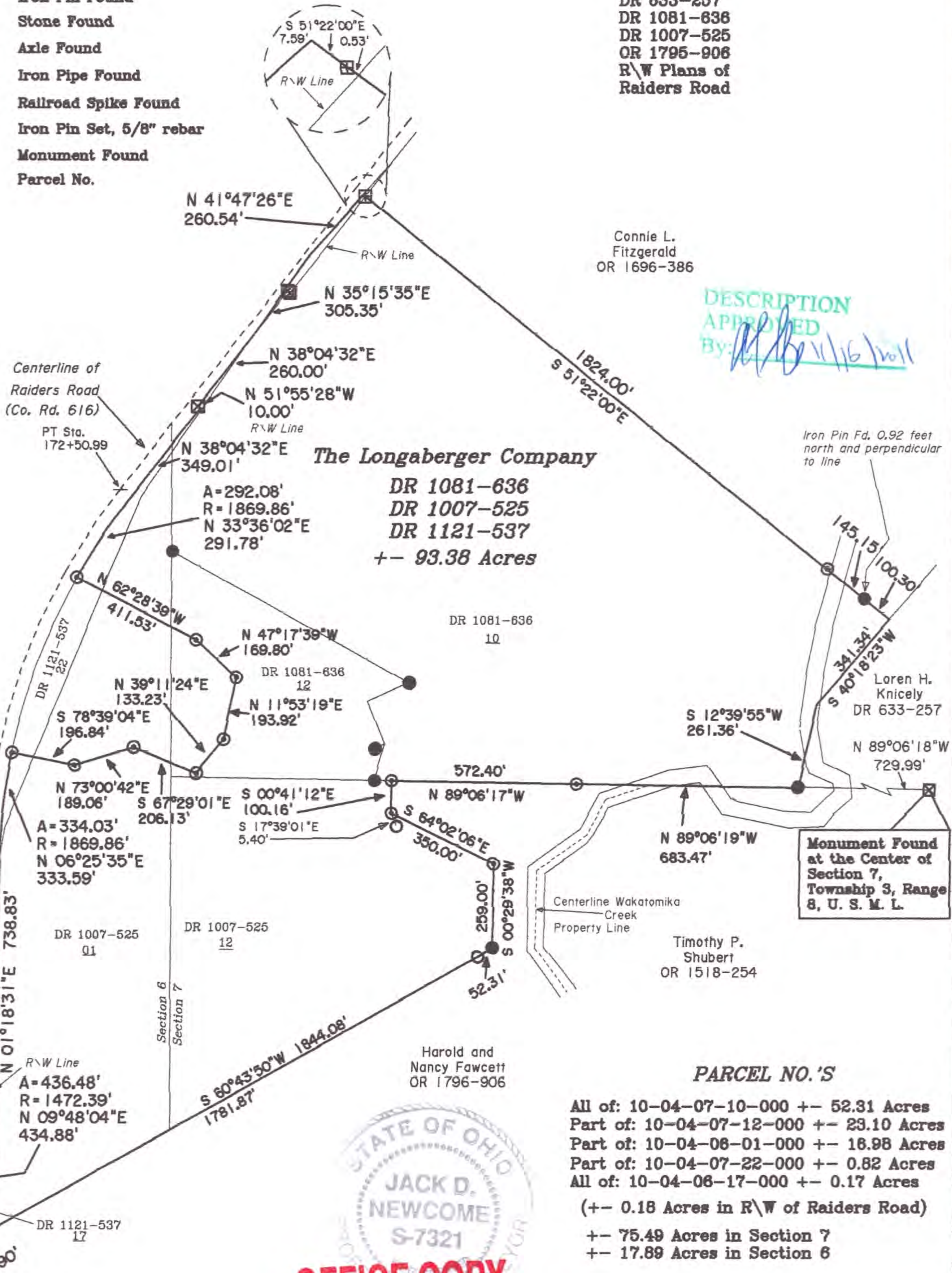

- 8.) South 02 degrees 09 minutes 03 seconds West, 738.83 feet to a point;
- 9.) Along a curve to the right having a radius of 1472.39 feet and an arc length of 446.99 feet, and a chord which bears South 10 degrees 50 minutes 52 seconds West, 445.27 feet to a point on the northwest corner of lands presently owned by Harold and Nancy Fawcett, (OR 1796-906);

Thence across Raiders Road, North 41 degrees 52 minutes 02 seconds West, 91.90 feet to the principal place of beginning, containing 7.68 acres more or less;

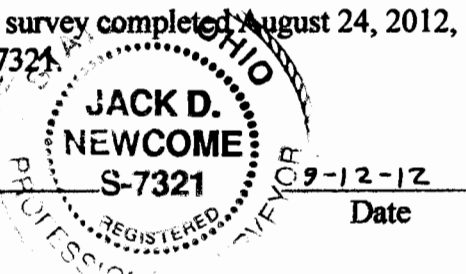

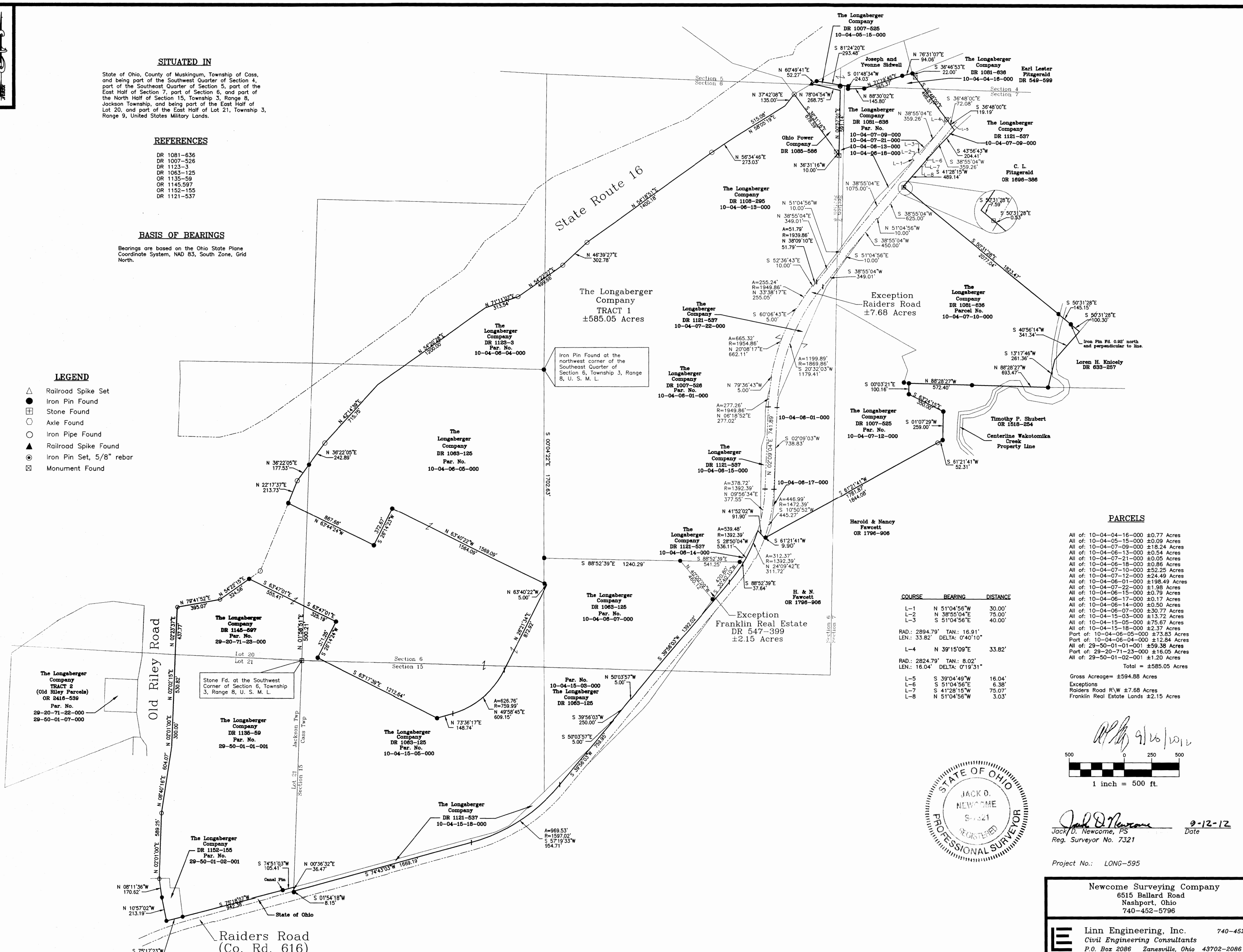

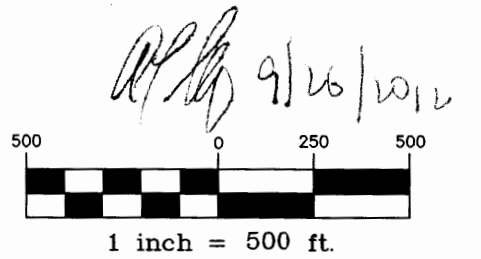
