## PARCEL ONE:

Being a part of the Southwest Quarter of Section Seven (7) in Township Three (3), Range Eight (8), United States Military Lands and being more particularly described as follows:

Commencing at a concrete monument found at the Northeast corner of the Southwest Quarter of said Section Seven (7), thence with the East line of the Southwest Quarter of Section (7), S.00°17'00" W. 2,274.06 feet to a 3/4 inch iron pipe set, said 3/4 inch iron pipeset being the true place of beginning of the land herein described; thence with the said East line of the Southwest Quarter of Section (7), S.00°17'00"W. 259.65 feet to a 3/4 inch iron pipe found on the North property line of the Consolidation Rail Corporation, (D.B. 760, page 126); thence with said North property line of the Consolidated Rail Corporation, S.66°17'00"W. 309.38 feet to a 3/4 inch iron pipe set, passing a 3/4 inch iron pipe set at 32.84 feet; thence through the property of John M. Krichbaum (D.B. 723, page 125), the following Four (4) courses:

1. N.00°17'00"E. 582.67 feet to a 3/4 inch iron pipe set;
2. S.89°00'00"E. 199.24 feet to a 3/4 inch iron pipe set;
3. S.02°16'21"E. 204.58 feet to a 3/4 inch iron pipe set;
4. N.82°51'25"E. 74.91 feet to the true place of beginning, containing 3.000 acres, more or less, passing a 3/4 inch iron pipe set at 44.66 feet.

EXCEPTING from the above described 3.000 acres a 30 foot right-of-way easement along the West side of the East line of the Southwest Quarter of Section (7) and running North from the North property line of the Consolidated Rail Corporation to the intersection of the North line of the above described 3.000 acres and the East line of the Southwest Quarter of Section (7) for the purpose of ingress and egress and utilities above and below ground and bounded and described as follows:

There is also conveyed herein a right-of-way and easement for ingress and egress over lands in the Southeast Quarter of Section Seven (7), said land being reserved to the use of owners of the land in the Southwest Quarter of Section Seven (7), in a certain Deed from Emma Fawcett to the Penn Central & St. Louis Railway, dated January 7, 1901, and recorded in Deed Book 123, page 120, of the Muskingum County Deed Records, said roadway having been reserved for the use and enjoyment of the owner or owners of property lying in said Southwest Quarter, said roadway to connect with a like roadway 20 feet in width extending along the right-of-way and connecting with said county road on a line
