Situated in the Southeast Quarter of Section #7, T-3-N, R-8-W, Cass Township, Muskingum County, Ohio. Being part of the lands of Williams Trailer Sales, Inc. as recorded in Deed Book 1108 Page 31 of the Muskingum County deed records and being described as follows:

Commencing at a stone found marking the Northeast corner of the Southeast quarter of section #7; thence, S.00°11'55"E. a distance of 350.39 feet along the East line of said quarter section to a point, located near the center of Township Road #118 (Schoolhouse Road), Being the point of beginning;

thence, S.00°11'55"E. a distance of 149.99 feet along the east line of said quarter section to a point;

thence, S.89°48'05"W. a distance of 275.00 feet through the lands of Williams Trailer Sales (1120/031) to a set rebar on the East line of the lands now or formerly, owned by S. & R. Bowman (1108/342), passing a set rebar at 27.58 feet;

thence, N.00°11'55"W. a distance of 149.99 feet along said Bowman lands to a set rebar;

thence, N.89°48'05"E. a distance of 275.00 feet through said Williams lands to the point of beginning, passing a set rebar at 244.90 feet.

The above described parcel contains 0.947 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars. North is based upon an assumed meridian.

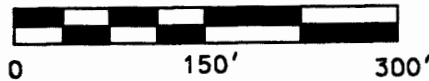
