BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 7, TOWNSHIP 3, RANGE 8, OF THE UNITED STATES MILITARY LANDS, CASS TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF SECTION 7,

THENCE WITH THE NORTH LINE OF THE SAID SOUTHEAST QUARTER AND THE CENTER OF TOWNSHIP ROAD 118 (SCHOOLHOUSE ROAD), NORTH 89 DEGREES 28 MINUTES 38 SECONDS WEST 889.33 FEET (DEED) TO A POINT, SAID POINT BEING THE **PLACE OF BEGINNING** OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE LEAVING THE CENTER OF SAID TOWNSHIP ROAD AND TRAVERSING THROUGH A TRACT CONVEYED TO S. AND J. LITTLE (DEED BOOK VOLUME 1156, PAGE 535), SOUTH 01 DEGREES 55 MINUTES 38 SECONDS EAST 174.77 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 25.00 FEET;

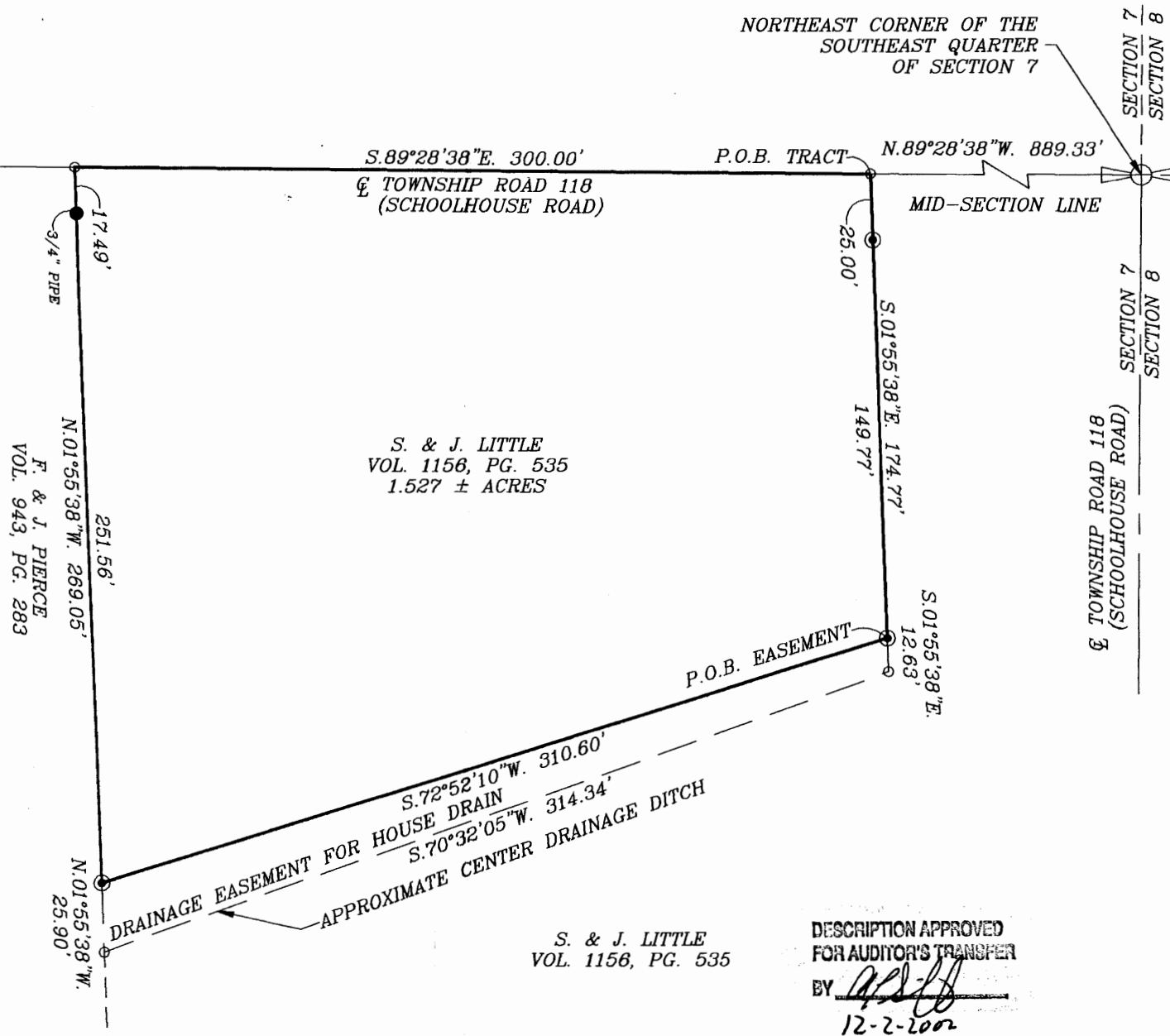
