Situated in the Northwest quarter of fractional section #13, quarter township #2, T-3-N, R-8-W, U.S.M.L., Cass Township, Muskingum County, Ohio. Being part of the lands of Rickey and Sharon Smith as conveyed in Deed Book 1007 page 370 of the Muskingum County Deed records and being described as follows:

Commencing at a found iron pin marking the Southwest corner of the Northwest quarter of fractional section #13; thence, N.04°35'05"E. a distance of 558.38 feet along the west line of said quarter section to a point in the center of Township Road #77 (Redbud Road), Being the point of beginning;

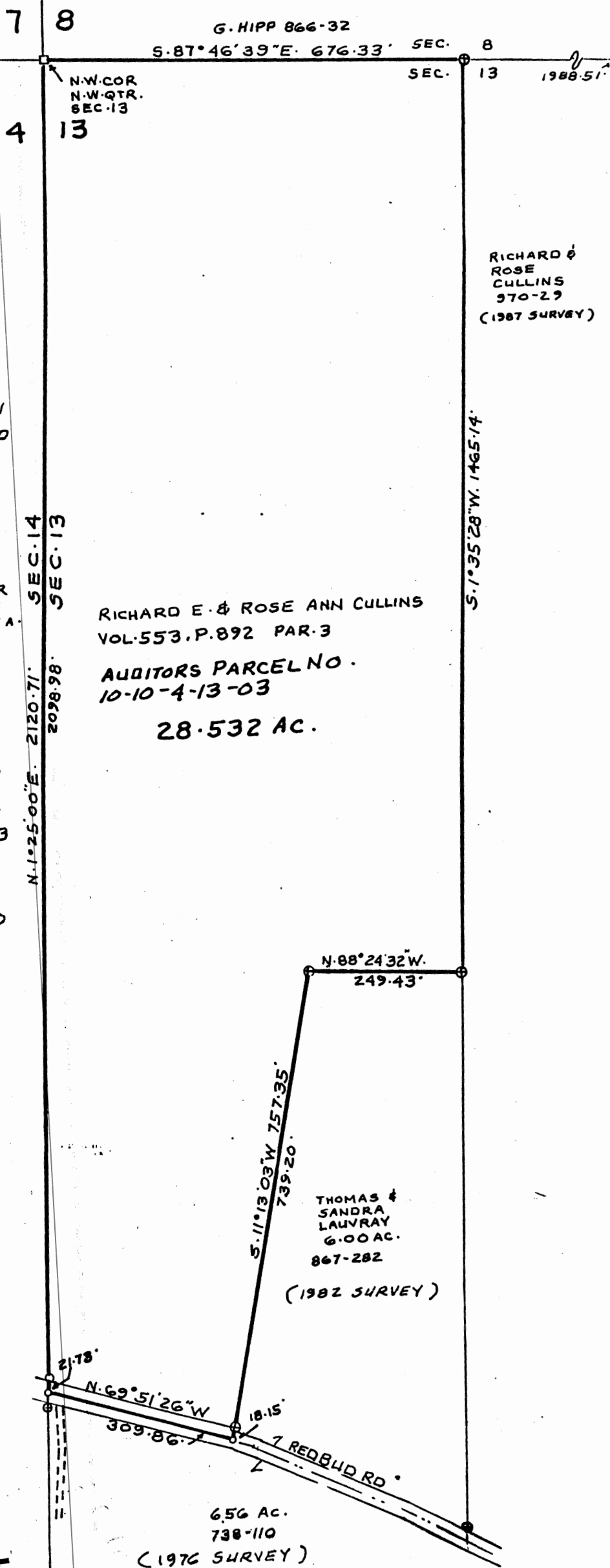
BASE OF BEARINGS
