Commencing at the Northeast Corner of said Lot number eight of Adam's First Addition as recorded in Plat Book two at page six and seven of the Muskingum County Plat Records; thence South 03 degrees 58 minutes 4 seconds East 3549.67 feet to a point in the center of Township Road number 401, said point being the place of beginning of this tract, passing points marked by iron pins at 2705.92 feet and 2332.96 feet; thence South 76 degrees 19 minutes 39 seconds East 142.28 feet to a point in the center of said road; thence South 69 degrees 14 minutes 57 seconds East 62.18 feet to a point in the center of said Township Road; thence South 73 degrees 27 minutes 57 seconds West 183.75 feet to a point marked by an iron pin, passing a point marked by an iron pin at 23.73 feet; thence South 79 degrees 25 minutes 08 seconds West 280.35 feet to a point marked by an iron pin; thence North 09 degrees 56 minutes 09 seconds East 203.50 feet to a point in the center of Township Road number 401, passing a point marked by an iron pin at 186.45 feet; thence South 78 degrees 50 minutes 29 seconds East 224.07 feet to the place of beginning.

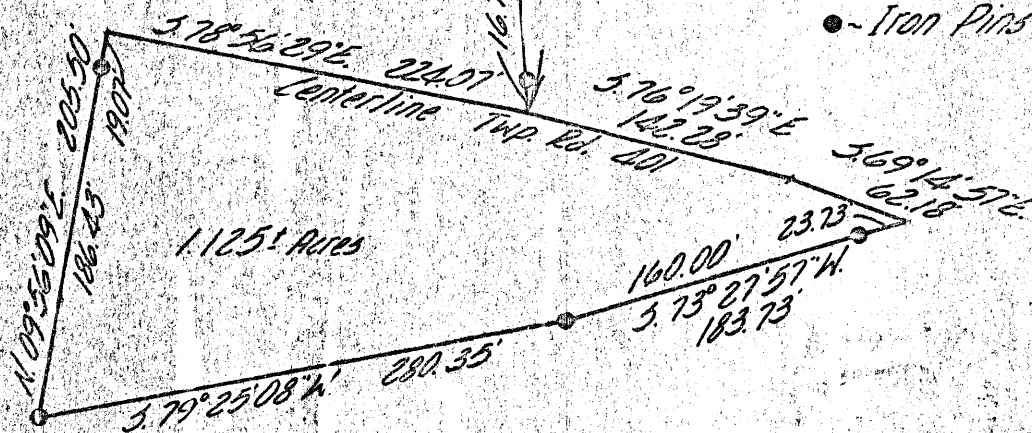
