CORRECTED DESCRIPTION

Being 26.399 acres, more or less, 16.287 acres in Lot 30, 3.315 acres in Lot 31 and 6.797 acres in Lot 32, Adams Subdivision, Plat Book 2, page 6, First Quarter, Township 3 North, Range 8 West, United States Military Lands, in Township of Cass, in the County of Muskingum, in the State of Ohio, conveyed to Charles E. and Lori Spiker (joint survivor), DR 2340-822 (remainder, TRACT TWO, FIRST PARCEL, all FOURTH PARCEL and remainder SIXTH PARCEL), Parcel No. 10-08-61-13-000 (all, 26.399 acres) and more particularly described as follows:

Commencing at a stone found (broken) at the Southwest corner of Lot 29, Adams Subdivision, Plat Book 2, page 6, said stone being the TRUE POINT OF BEGINNING:

thence, with the South line of Lot 29, Adams Subdivision, Plat Book 2, page 6, S. 88° 40' 33" E. a distance of 1317.92' to a $\frac{5}{8}$ " rebar set;

thence, with the property line of Ohio Rail Development Commission, DR 2397-658, S. 76° 09' 57" W. a distance of 1624.64' to a $\frac{5}{8}$ " rebar found;

thence, with the property line of Aaron C. and Amber Naber, DR 2860-91, N. 15° 49' 35" W. a distance of 865.66' to a $\frac{5}{8}$ " rebar found;

thence, with the West line of Lot 29, Adams Subdivision, Plat Book 2, page 6, S. 00° 44' 36" W. a distance of 1351.75' to the TRUE POINT OF BEGINNING, containing 26.399 acres, more or less and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied.
