

Steven C. Brennen OR 2397-755 +/-5.000 Ac.

Being a part of the First Quarter of Township, Township 3, Range 8, Cass Township, Muskingum County, State of Ohio also being part of the lands now owned by Steven C. Brennen (OR 2397-755) of the Muskingum County Recorder more fully described as follows.

Beginning for reference at an iron pin found on the southwest corner of said Lot 32; thence with the west line of said Lot 32, North 00 degrees 42 minutes 17 seconds East, 918.12 feet to an iron pin set on said west lot line, passing an iron pin found at 30.00 feet;

thence continuing with said west lot line, North 00 degrees 42 minutes 17 seconds East, 318.84 feet to a point in the center of Narrows Rd. (CR-76), passing an iron found at 278.11 feet;

thence with the center of said Narrows Rd. the following three (3) courses:

- 1. North 87 degrees 37 minutes 32 seconds East, 186.03 feet to a point;
- 2. South 87 degrees 37 minutes 50 seconds East, 158.08 feet to a point;
- 3. South 83 degrees 39 minutes 28 seconds East, 346.89 feet to a point;

thence through said Steven C. Brennen's lands the following two (2) courses:

- 1. South 00 degrees 42 minutes 17 seconds West, 290.16 feet to an iron pin set, passing an iron pin set at 30.00 feet;
- 2. North 89 degrees 17 minutes 43 seconds West, 688.99 feet to the point of beginning, containing 5.000 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.

The above described 5.000 acre parcel is based on a field survey made by McPeek Land Surveying on June 17th, 2013.
