Being part of the lands conveyed to Richard and Ricky Lacy in Deed Book 998 page 370 and conveyed to Gleason Lacy in deed book 376 page 073 of the Muskingum County deed records and being described as follows:

Beginning at a stone found marking the Southeast corner of lot #18;  
thence, S.88°11'24"E. a distance of 422.50 feet along the South line of the lands, now or formerly, owned by C. Lane (1002/081) to a set iron pipe;  
thence, S.01°48'35"W. a distance of 236.78 feet to a set iron pipe on the West line of the lands, now or formerly, owned by D. Fulks (543/435), also being the Northeast corner of the railroad lands owned by Caprail I, Inc.;  
thence, S.76°29'00"W. a distance of 511.00 feet along a North line of said Railroad lands to a set rebar;  
thence, S.13°31'00"E. a distance of 206.00 feet along the West line of said Railroad lands to a set rebar;  
thence, S.76°29'00"W. a distance of 1,286.25 feet along a North line of said Railroad lands to the Southeast corner of the lands, now or formerly, owned by R. & R. Lacy (998/368);  
thence, N.21°34'13"W. a distance of 999.72 feet along the easterly line of said Lacy lands to a set rebar;  
thence, N.21°44'36"E. a distance of 728.75 feet through the lands of R. & R. Lacy (998/370) and G. Lacy (376/073) to a set rebar;  
thence, N.67°57'13"E. a distance of 967.20 feet through said Lacy lands to a set rebar;  
thence, N.05°22'48"W. a distance of 200.22 feet through said Lacy lands to a set rebar on the South line of the Ohio Canal lands;  
thence, N.82°47'58"E. a distance of 32.09 feet along said Canal lands to a set rebar;  
thence, N.73°17'02"E. a distance of 244.67 feet along said Canal lands to a set rebar;  
thence, N.72°06'48"E. a distance of 298.22 feet along said Canal lands to a set rebar on the Northwest corner of the lands, now or formerly, owned by C. Lane (1002/081);  
thence, S.01°46'59"W. a distance of 1,465.32 feet along the West line of said Lane lands to the place of beginning.

The above described parcel contains 64.527 acres, more or less, (27.816 acres in lot #8, 4.408 acres in lot #17, and 32.303 acres in lot #18) and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars. North is based upon an assumed meridian.

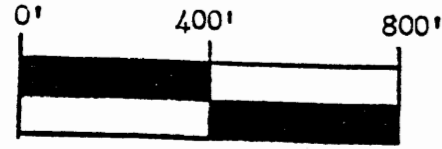

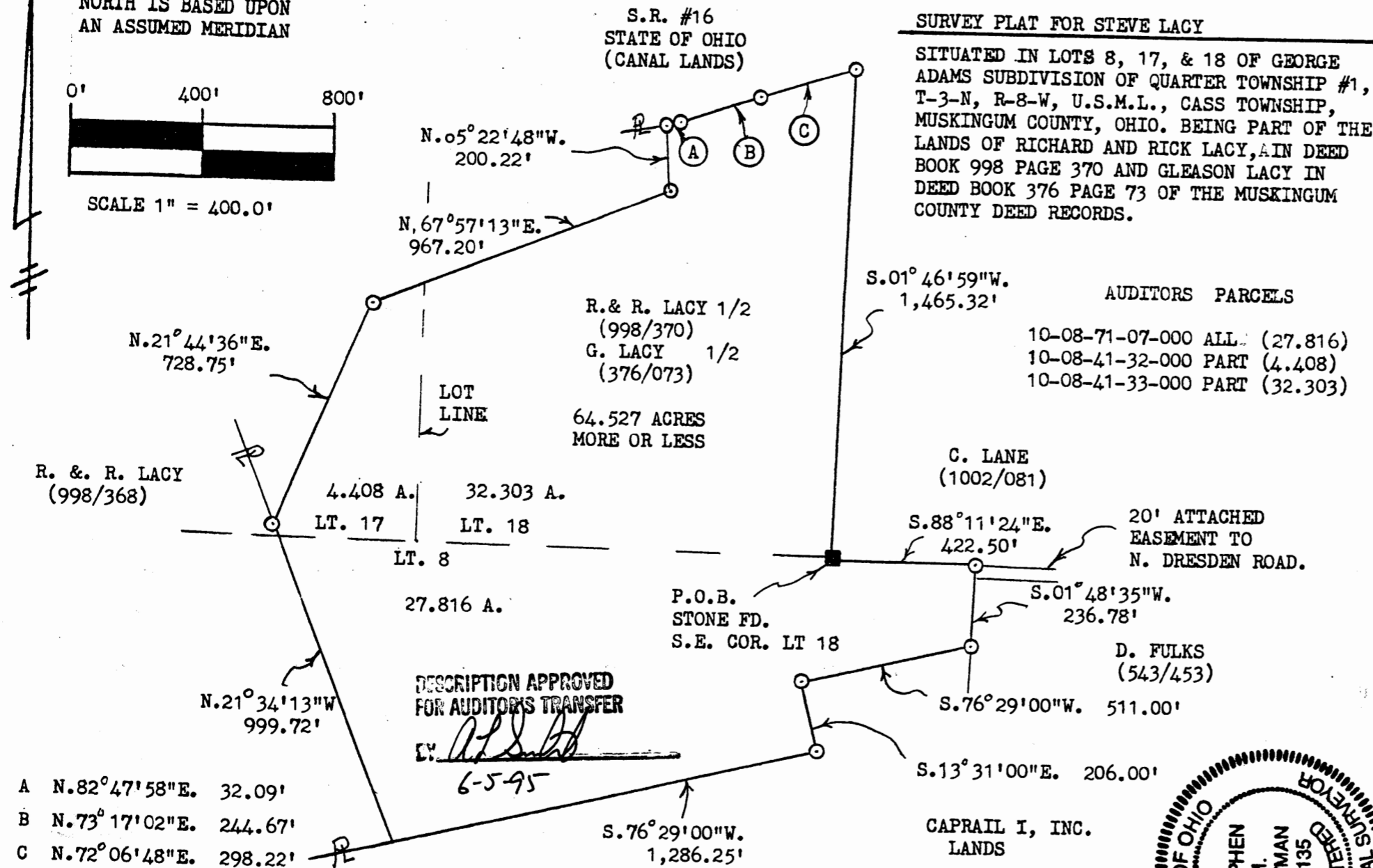
NORTH IS BASED UPON AN ASSUMED MERIDIAN

Also attached to the above described parcel is a 20 foot right of way to North Dresden road along the South line of lot #18 being described as follows:

Commencing at a stone found on the Southwest corner of lot #18; thence, S.88°11'24"E. a distance of 423.06 feet along the South line of lot #18 to a set iron pipe, BEING THE POINT OF BEGINNING;

thence, S.01°48'35"W. a distance of 20.00 feet along the East line of R. & R. lacy (998/370) and G. Lacy (376/073) to a found iron pipe on the Northwest corner of the lands, now or formerly, owned by D. Fulks (543/453);

thence, S.88°11'24"E. a distance of 253.10 feet along the North line of said fulks lands to a point in the center of C.R. #706 (N. Dresden Rd.) passing a found iron pipe at 223.10 feet;

thence, N.40°11'21"E. a distance of 25.51 feet along the center of said road to a point;

thence, N.88°11'24"W. a distance of 268.94 feet along the South line of the lands, now or formerly, owned by C. Lane (1002/081) to the point of beginning, passing a set iron pipe at 35.00 feet.

The above described easement covers 0.120 acres, more or less. Subject to all legal easements and right of ways. All set iron pipes are 3/4" x 30" pipes with plastic I.D. caps, All set rebars are 5/8" x 30" rebars. North is based upon an assumed meridian.
