Commencing at the Northwest Corner of Lot 1 in George Adams Subdivision as recorded in Plat Book 2, Page 6; thence north 77 degrees 09 minutes west 50 feet to a point; thence south 12 degrees 51 minutes west 2606.48 feet to a point on the west line of the railroad and the centerline of Bottom Road; thence north 37 degrees 19 minutes west 101.04 feet to a point in said centerline and the true place of beginning of the premises herein intended to be described; thence south 52 degrees 41 minutes west 220 feet to an iron pin; thence north 37 degrees 19 minutes west 120 feet to an iron pin; thence north 52 degrees 41 minutes east 220 feet to a point in the center of Bottom Road; thence along said centerline south 37 degrees 19 minutes east 120 feet to the true place of beginning, containing sixty-one hundredths (0.61) of an acre more or less.

Subject to the easements of Bottom Road.

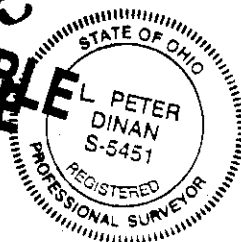

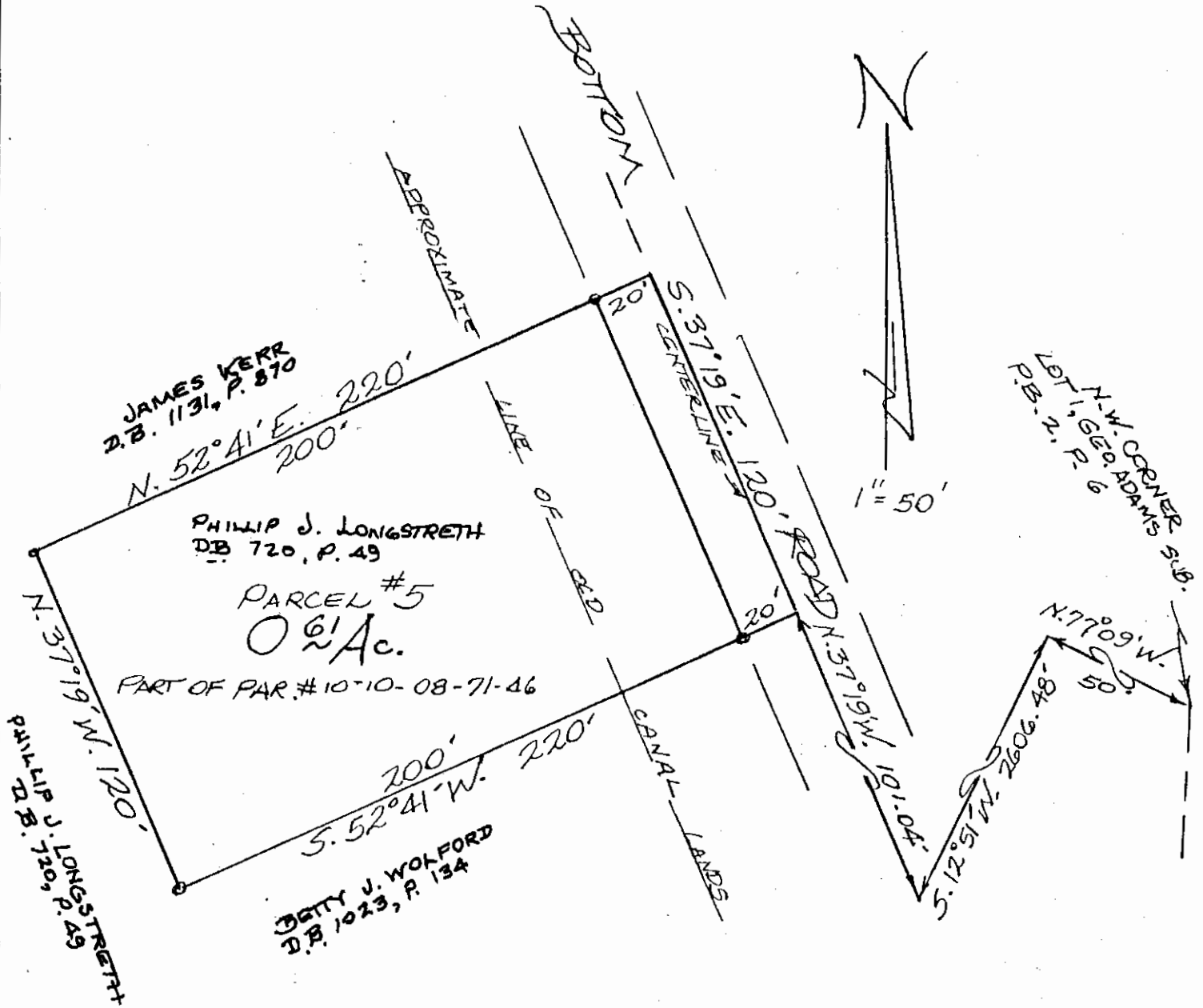

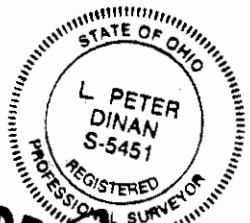
