BEING A PART OF LOT 21 AND ALL OF LOT 18 AND LOT 19 OF H.A. SMITH'S FARM (COMMON PLEAS COURT RECORD BOOK 73) SITUATED IN QUARTER TOWNSHIP 1, TOWNSHIP 3, RANGE 7, OF THE UNITED STATES MILITARY LANDS, CASS TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (1/2 INCH PIPE) ON THE COSHOCTON AND MUSKINGUM COUNTY LINE AT THE NORTHWEST CORNER OF QUARTER TOWNSHIP 1, TOWNSHIP 3, RANGE 7;

THENCE WITH THE NORTH LINE OF THE SAID QUARTER TOWNSHIP, SOUTH 86 DEGREES 46 MINUTES 42 SECONDS EAST 2579.09 FEET TO A POINT, PASSING AN EXISTING STONE AT 1601.10 FEET;

THENCE LEAVING THE SAID NORTH LINE, SOUTH 00 DEGREES 16 MINUTES 57 SECONDS EAST 713.36 FEET TO A POINT ON THE SOUTH RIGHT OF WAY LINE OF OHIO CENTRAL RAILROAD (FORMERLY NORFOLK AND WESTERN RAILROAD), SAID POINT BEING THE PLACE OF BEGINNING FOR THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE WITH THE EASTERLY LINES OF H.A. SMITH'S FARM LOTS 21 AND 18 AND THE WEST LINE OF A TRACT CONVEYED TO THREE SPRINGS FARM LLC. (VOLUME 2046, PAGE 522 OF THE MUSKINGUM COUNTY DEED RECORDS) THE FOLLOWING SEVEN COURSES AND DISTANCES:

1. SOUTH 00 DEGREES 16 MINUTES 57 SECONDS EAST 342.15 FEET A POINT, PASSING AN EXISTING MONUMENT AT 28.93 FEET, AND AN IRON PIN SET AT 317.15 FEET;
2. SOUTH 87 DEGREES 00 MINUTES 25 SECONDS EAST 705.56 FEET TO AN EXISTING STONE;
3. SOUTH 07 DEGREES 37 MINUTES 23 SECONDS EAST 400.95 FEET TO A POINT, SAID POINT BEING SOUTH 67 DEGREES 52 MINUTES 05 SECONDS WEST 14.06 FEET FROM AN IRON PIN SET;
4. SOUTH 17 DEGREES 31 MINUTES 45 SECONDS EAST 404.55 FEET TO A POINT, SAID POINT BEING SOUTH 56 DEGREES 09 MINUTES 40 SECONDS WEST 10.36 FEET FROM AN IRON PIN SET;
5. SOUTH 23 DEGREES 18 MINUTES 12 SECONDS EAST 614.12 FEET (615.95 FEET - DEED) TO AN EXISTING MONUMENT ON THE NORTHWEST BANK OF THE OLD MUSKINGUM RIVER CHANNEL;
6. SOUTH 14 DEGREES 57 MINUTES 02 SECONDS EAST 1357.97 FEET (1355.85 FEET - DEED) TO AN EXISTING MONUMENT AT THE SOUTH END OF THE OLD MUSKINGUM RIVER CHANNEL;
7. SOUTH 57 DEGREES 18 MINUTES 19 SECONDS EAST 664.62 FEET TO AN EXISTING CONCRETE POST, SAID CONCRETE POST BEING NORTH 74 DEGREES 06 MINUTES 00 SECONDS WEST 603.72 FEET (603.58 FEET - DEED) FROM AN EXISTING CONCRETE MONUMENT;

THENCE LEAVING THE SAID WEST LINE AND WITH THE NORTH LINE OF TRACTS CONVEYED TO MONROE HILL FARMS (O.R. VOLUME 1645, PAGE 751 AND O.R. VOLUME 1617, PAGE 469), NORTH 87 DEGREES 05 MINUTES 30 SECONDS WEST 3013.85 FEET TO AN EXISTING CONCRETE POST, PASSING AN EXISTING IRON PIN (3/4 INCH ROD) AT 484.93 FEET, AND AN EXISTING CONCRETE POST AT 1753.77 FEET;

4. WITH THE SOUTH LINE OF H.A. SMITH'S FARM LOT 21, SOUTH 89 DEGREES 31 MINUTES 29 SECONDS WEST 835.06 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH CAP);

THENCE LEAVING THE SAID EAST LINE OF THE MONROE HILL FARMS TRACT AND WITH THE EAST LINE OF A TRACT CONVEYED TO E.G. MCMORROW (O.R. VOLUME 1871, PAGE 355) AND A TRACT CONVEYED TO M.M. GRAY (DEED VOLUME 1068, PAGE 55), NORTH 02 DEGREES 22 MINUTES 54 SECONDS EAST 739.27 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH CAP);

THENCE WITH THE EAST LINE OF A TRACT CONVEYED TO MONROE HILL FARMS (O.R. VOLUME 1645, PAGE 751) THE FOLLOWING TWO COURSES AND DISTANCES:
