thence South 35° 35' 37" East, along the East line of a tract conveyed to Bryan D. and Amy Jo Little by a deed recorded in Deed Book 1161, page 20, a distance of 371.20 feet to a point:

thence with a curve to the left having a radius of 117.62 feet (a chord bearing and distance of South 75° 13' 54" East 155.66 feet) an arc distance of 170.10 feet, along the East line of said Little tract and along the North line of a tract conveyed to Larry S. and Kindra L. Neff by a deed recorded in Deed Book 1161, page 23, to a point;

thence North 61° 32' 25" East, continuing along the North line of said Neff tract, a distance of 309.11 feet to a point;
