

thence continuing South 15° 36' 45" East, along the East line of said Stotts tract, a distance of 27.10 feet to a point, **being the true place of beginning of this right of way;**

thence continuing South 15° 36' 45" East, along the East line of said Stotts tract, a distance of 60.00 feet to a point;

thence South 35° 35' 37" East, along the East line of a tract conveyed to Bryan D. and Amy Jo Little by a deed recorded in Deed Book 1161, page 20, a distance of 371.20 feet to a point;

thence with a curve to the left having a radius of 117.62 feet (a chord bearing and distance of South 75° 13' 54" East 155.66 feet) an arc distance of 170.10 feet, along the East line of said Little tract and along the North line of a tract conveyed to Larry S. and Kindra L. Neff by a deed recorded in Deed Book 1161, page 23, to a point;

thence North 61° 32' 25" East, continuing along the North line of said Neff tract, a distance of 289.50 feet to a point;

thence the following five (5) courses through the aforementioned Taylor tract

- 1.) North 28° 27' 35" West a distance of 25.00 feet to an iron pin set;
- 2.) North 61° 32' 25" East a distance of 19.61 feet to a point;
- 3.) with a curve to the right having a radius of 125.00 feet (a chord bearing and distance of North 83° 45' 03" East 97.74 feet) and arc distance of 100.42 feet to a point;

- 5.) with a curve to the left having a radius of 265.17 feet (a chord bearing and distance of South 80° 28' 43" East 90.82 feet) an arc distance of 91.27 feet to a point;
- 6.) North 89° 40' 09" East a distance of 172.87 feet to a point in the center of Township Road 91 (North Morrison Road);

thence South 01° 05' 42" East, along the center of Township Road 91 (North Morrison Road), a distance of 25.01 feet to a point;

thence South 01° 10' 34" East, continuing along the center of Township Road 91 (North Morrison Road), a distance of 25.00 feet to a point;

thence South 89° 40' 09" West, through a tract conveyed to Thomas A. and Amy L. Wilcox by a deed recorded in Deed Book 1734, page 873, a distance of 173.57 feet to a 5/8 inch rebar found;

thence with a curve to the right having a radius of 315.16 feet (a chord bearing and distance of North 80° 37' 07" West 106.27 feet) an arc distance of 106.78 feet, through said Wilcox tract, to a point;

thence North 72° 33' 07" West, continuing through said Wilcox tract and through the aforementioned Neff tract, a distance of 486.42 feet to a 5/8 inch rebar found;

thence with a curve to the left having a radius of 75.00 feet (a chord bearing and distance of South 83° 15' 26" West 58.74 feet) an arc distance of 60.36 feet, through said Neff tract, to a 5/8 inch rebar found;
