Commencing at a stone (found) at the Northeast corner of said Lot #22; thence along the North line of said Lot #22 N 87 38 49 W 1197.50 feet to the center of Township Road #117 (Airy View Drive); thence through said Lot #22, and along said road S 01 57 16 W 412.25 feet to an iron pin (set) at a corner of said 10.000 acre parcel and at the place of beginning for the property herein intended to be described; thence continuing along said road and a line of said 10.000 acre parcel S 01 57 16 W 128.82 feet to an iron pin (set); thence continuing along said road and through said 10.000 acre parcel S 01 57 16 W 220.64 feet to an iron pin (set) on the South line of said 10.000 acre parcel; thence along said South line N 88 02 44 W 623.25 feet to an iron pin (set); thence through said 10.000 acre parcel N 01 57 16 E 349.47 feet to an iron pin (set) on the North line of said 10.000 acre parcel; thence along said North line S 88 02 44 E 623.25 feet to the place of beginning containing 5.000 acres.

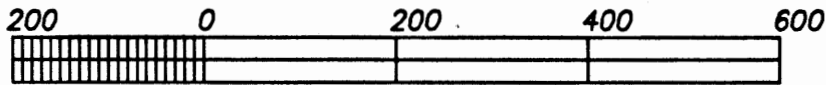
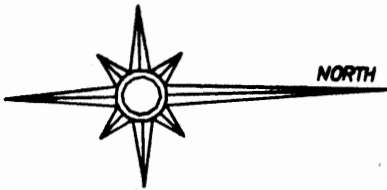
SURVEY PLAT FOR TAD & BETTY ANTHONY

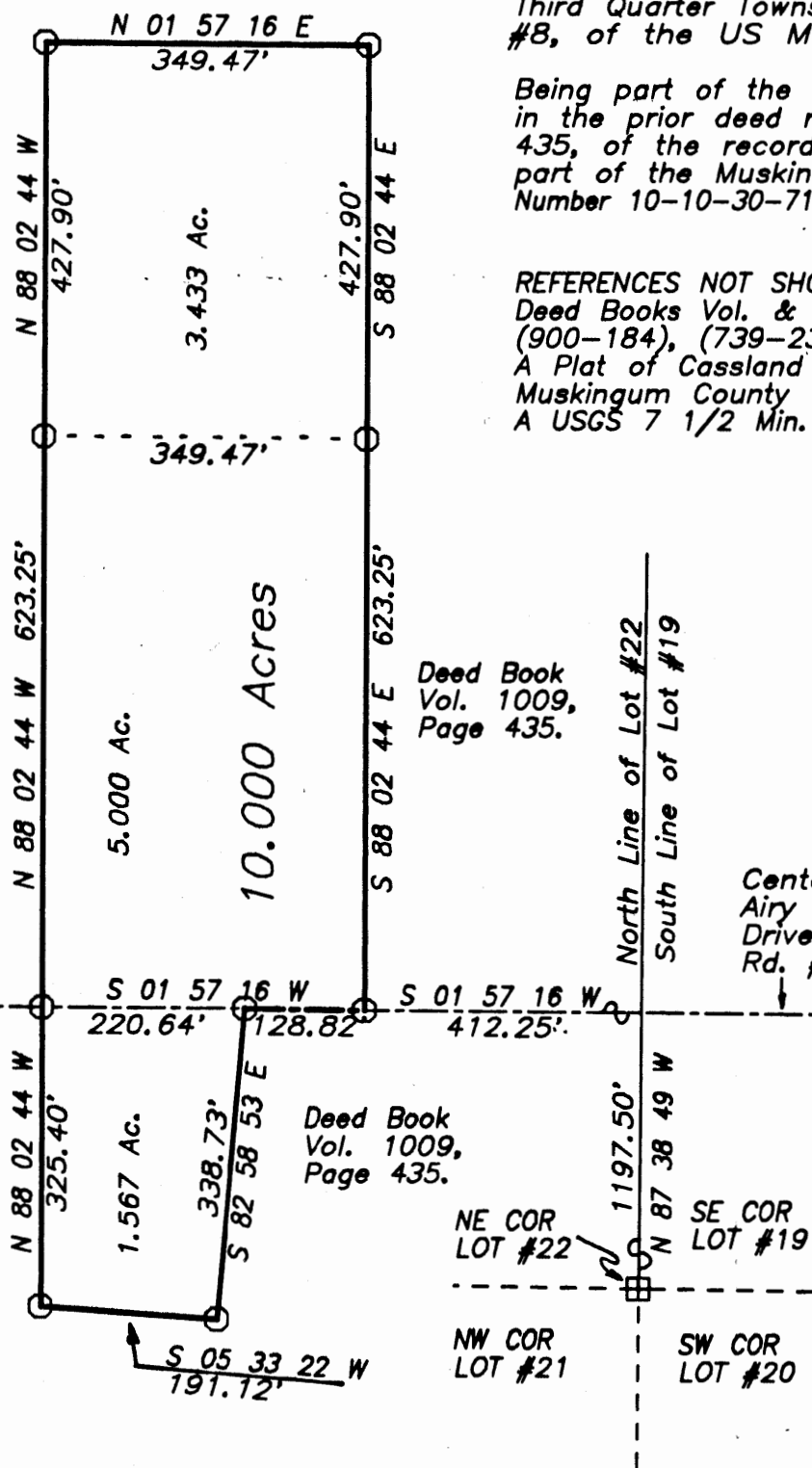
