thence South 73 degrees 55 minutes 36 seconds West 83.42 feet to an iron pin set; thence South 71 degrees 08 minutes 48 seconds West 137.61 feet to a PK nail set; thence on a curve to the right having a radius of 20.00 feet, a central angle of 37 degrees 25 minutes 44 seconds and a chord bearing North 14 degrees 41 minutes 14 seconds West a distance of 12.83 feet to a PK nail set; thence North 04 degrees 01 minutes 38 seconds East 111.65 feet to a PK nail set; thence on a curve to the right having a radius of 20.00 feet, a central angle of 87 degrees 15 minutes 21 seconds and a chord bearing North 47 degrees 39 minutes 19 seconds East a distance of 27.60 feet to a PK nail set; thence South 88 degrees 43 minutes 01 seconds East 154.18 feet to a PK nail set; thence on a curve to the right having a radius of 20.00 feet, a central angle of 75 degrees 37 minutes 38 seconds and a chord bearing South 50 degrees 54 minutes 12 seconds East a distance of 24.52 feet to a PK nail set; thence South 13 degrees 05 minutes 23 seconds East 51.79 feet to a PK nail set; thence on a curve to the right having a radius of 20.00 feet, a central angle of 15 degrees 44 minutes 09 seconds and a chord bearing South 05 degrees 13 minutes 19 seconds East a distance of 5.48 feet to a PK nail set and the principal place of beginning, containing 0.49 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.
