Situate in the State of Ohio, County of Muskingum, Township of Cass, and being a part of Lot #5 and Lot # 14, in the Fourth Quarter Township, Township 3 North, Range 8 West, in the United States Military District and being part of parcel # 10 - 34 - 41 - 27 as conveyed to Mitchell and Gail Taylor in Deed Volume 1157, Page 912, and parcel # 10 - 34 - 41 - 29 as conveyed to Mitchell and Gail Taylor in Deed Volume 1157, Page 912 of the Muskingum County Deed Records, and being more particularly bounded and described as follows:

Beginning for reference at an iron pin found at the Northwest corner of Lot #5, of the Fourth Quarter Township, Township 3 North, Range 8 West, in the United States Military District, thence South 00 degrees 55 minutes 08 seconds East 1484.42 feet to an iron pin found at the Southwest corner of M. And G. Taylor property (Vol. 1086, Pg. 503); thence South 90 degrees 00 minutes 00 seconds East 173.29 feet to a point; thence South 00 degrees 55 minutes 08 seconds East 826.03 feet to a point in the centerline of Dutch Hill Road (Twp. Rd. # 80); thence along said centerline North 56 degrees 44 minutes 26 seconds East 46.25 feet to a point; thence along said centerline North 50 degrees 28 minutes 39 seconds East 143.07 feet to a point; thence North 44 degrees 55 minutes 32 seconds East 12.14 feet to a point in the centerline of Dutch Hill Road (Twp. Rd. # 80); thence leaving said centerline North 78 degrees 36 minutes 25 seconds East 894.09 feet to an iron pin set, passing an iron pin found at 35.00 feet, and the True Place of Beginning; thence along the line between M. and T. Carter (Vol. 1157 Pg. 405) and Mitchell and Gail Taylor (Vol. 1157 Pg. 912) North 78 degrees 36 minutes 25 seconds East 205.94 feet to an iron pin found in the line of said M. and T. Carter property (Vol. 1157 Pg. 405) and Mitchell and Gail Taylor (Vol. 1157 Pg. 912); thence North 00 degrees 00 minutes 00 seconds East 131.63 feet to an iron pin found in the line between said Carter property and Taylor property; thence North 90 degrees 00 minutes 00 seconds East 1237.50 feet to an iron pin found; thence along the line between R. Henthorne ETAL (Vol. 698 Pg. 80) South 01 degrees 43 minutes 39 seconds East 808.41 feet to an iron pin set; thence along the line between said Taylor property and W. Orwig (Vol. 565 Pg. 724) South 01 degrees 02 minutes 38 seconds East 992.87 feet to an iron pin set; thence South 89 degrees 30 minutes 52 seconds West 1481.89 feet to an iron pin set; thence leaving said W. Orwig property on a new line North 00 degrees 00 minutes 00 seconds East 1640.99 feet to the True Place of Beginning, passing the south line of an easement 25.00 feet wide at 1615.49 feet.

Containing 60.000 Acres, more or less, (33.569 Acres of parcel # 10 - 34 - 41 - 29, more or less) and (26.431 Acres of parcel # 10 - 34 - 41 - 27, more or less), subject to all easements, restrictions, or right of ways, either written or implied. All iron pins set are 30 inch long by 5/8 inch diameter rebar with a yellow cap labeled "BINCKLEY S-7879".

Rd. # 80), and the True Place of Beginning; thence along said centerline North 56 degrees 44 minutes 26 seconds East 46.25 feet to a point; thence along said centerline North 50 degrees 28 minutes 39 seconds East 143.07 feet to a point; thence North 44 degrees 55 minutes 32 seconds East 12.14 feet to a point in the centerline of Dutch Hill Road (Twp. Rd. # 80) and the True Place of Beginning; thence leaving said centerline North 78 degrees 36 minutes 25 seconds East 894.09 feet to an iron pin set, passing an iron pin found at 35.00 feet; thence along a new line South 00 degrees 00 minutes 00 seconds East 25.50 feet to a point; thence along a new line South 78 degrees 36 minutes 25 seconds West 933.32 feet to a point in the centerline of Dutch Hill Road (Twp. Rd. # 80); thence North 50 degrees 28 minutes 39 seconds East 38.74 feet to a point; thence North 44 degrees 55 minutes 32 seconds East 12.14 feet to a point and the True Place of Beginning.

Bearings contained herein are assumed from a previous survey by Steven Bowman of the West Line of Lot # 5 as being South 00 degrees 55 minutes 08 seconds East and are for angular measurement only.

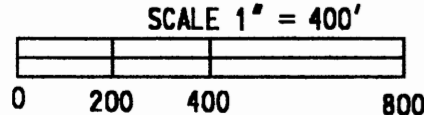

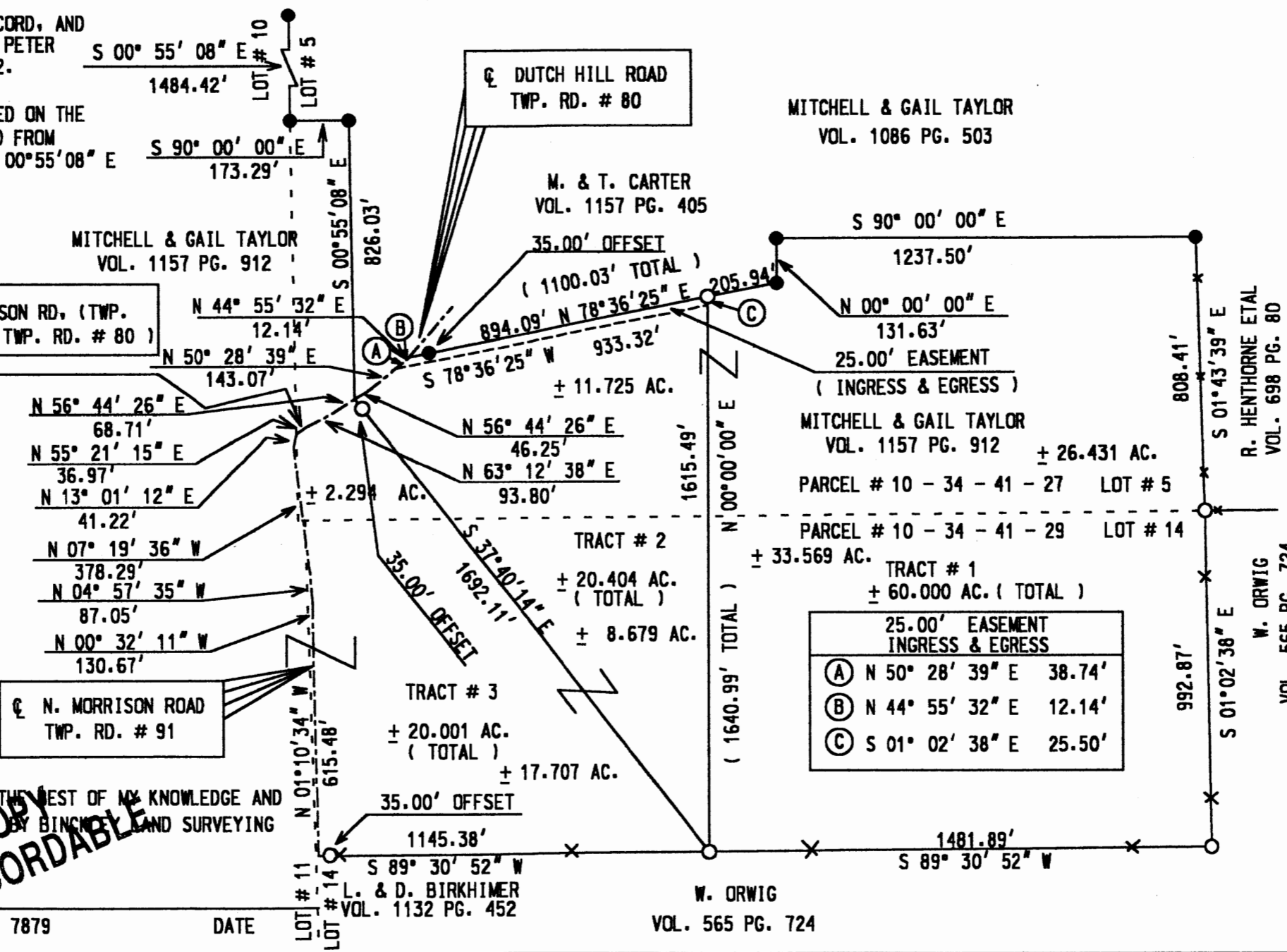
