Commencing at a stone found at the southwest corner of Lot 12; thence S 87° 11' 42" E (the base of bearing for this description is true north by an observation of the sun) along the south line of Lot 12 a distance of 996.39 feet to an iron pin found at the southeast corner of a 19.14 acre parcel owned by Mark and Rebecca Moody (Vol. 995, pg. 593); thence N 14° 15' 49" W along the easterly line of said Moody property and the east line of a 0.86 acre parcel owned by Richard and Mary Wagner (Vol. 1029, pg. 115) a distance of 872.46 feet to an iron pin found at the southwest corner of a 1.00 acre parcel owned by Bruce and Ronda Kurtz (Vol. 1157, pg. 754); thence N 75° 44' 11" E along the south line of said Kurtz parcel and the south line of a 1.00 acre parcel owned by Steven Barr (Vol. 1159, pg. 488) a distance of 222.67 feet to an iron pin found; thence N 79° 43' 36" E along the south line of a 1.00 acre parcel 112.88 feet to an iron pin set at the true place of beginning for the following described parcel; thence N 14° 15' 49" W 389.02 feet to a point in the center of State Route 60 and passing through an iron pin set at 209.02 feet and at 359.02 feet; thence along the center of said State Route 60 on a curve to the left having a radius of 5729.58 feet (the chord of which bears N 76° 42' 55" E 97.30 feet) an arc distance of 97.30 feet to a point; thence N 76° 13' 44" E along the center of said State Route 13.89 feet to a point; thence S 14° 15' 49" E 395.00 feet to an iron pin set and passing through an iron pin set at 30.00 feet and through an iron pin set at 180.00 feet; thence S 79° 43' 36" W 111.45 feet to the true place of beginning containing One and no hundredths acres (1.00).
