Beginning at the northwest corner of said Lot 24 at an existing iron pin; thence south 80 degrees 24 minutes 12 seconds east along the northerly line of said Lot 24 and along the southerly line of lands now or formerly owned by R. Miles and recorded in Deed Book 735, page 163 of the deed records of said county a distance of 1233.87 feet to an iron pin; thence south 00 degrees 38 minutes 07 seconds west along the westerly line of lands now or formerly owned by Rosemary Zack and recorded in Deed Book 544, page 295 of the deed records of said county a distance of 459.15 feet to an existing iron pin; thence north 80 degrees 51 minutes 30 seconds west along the northerly line of lands now or formerly owned by R. and G. Scurlock and recorded in Deed Book 504, page 564, of the Deed Records of said county a distance of 1301.75 feet to a point in the centerline of township road 153 and on the westerly line of said Lot 24 and on the easterly line of lands now or formerly owned by Dale Graham and recorded in Deed Book 433, page 337 of the Deed Records of said county and passing through an existing iron pin at 1278.15 feet; thence north 09 degrees 08 minutes 30 seconds east along said centerline and along said westerly line of said lot and along the easterly line of said Graham property a distance of 463.90 feet to the true place of beginning, containing thirteen and thirty-six (13.36) hundredths acres more or less.

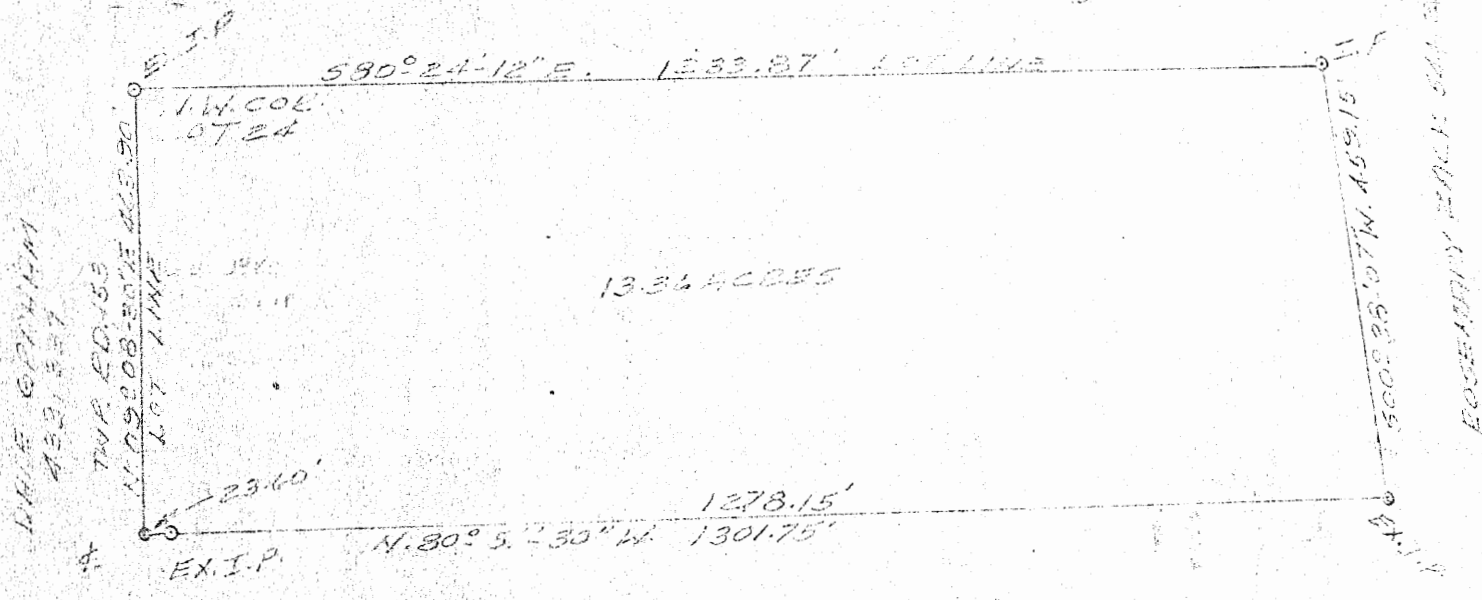
