Commencing at an iron pin set at the southeast corner of Lot 22; thence **N 87°58'56"W** (the base of bearings for this description is (The Ohio State Plane Grid System NAD 83 South Zone) along the south line of said Lot **562.76** feet to a monument found on the east line of NORTHPOINTE DRIVE (P.B. 19, Pg.125); thence **N 88°00'37"W** and crossing said drive **200.07** feet to a monument found on the west line of said road and the true place of beginning; thence **N 87°58'55"W** along the south line of said Lot 22 and the north line of property owned by Patrick J. Romine (O.R. 2571, Pg. 85) a distance of **236.90** feet to an iron pin found; thence **N 16°58'55"W** along properties owned by James and Martha Goslin (O.R. 1648, Pg. 818) and the east line of Joseph and Lisa Butler (O.R.1822, Pg. 173) and the east line of property owned by Aaron and Bobbi Davis (Vol. 1148, Pg. 46) a distance of **1207.24** feet to a point in the center of McGlade School Road and passing through an iron pin found at **1182.24** feet; thence along McGlade School Road and the east line of property owned by Appalachian Power (O.R. 2400, Pg. 670) the following 3 courses and distances:

1-N 52°30'56"E 328.64 feet to an iron pin found on the east side of said road

2-N 24°09'05"E 286.99 feet to a point in the center of said road, said point bears **N 64°18'20"W 19.67** feet from an iron pin set

3- N 23°45'07"E 682.36 feet to a railroad spike found; thence along the center of said road and the east line of a 0.695 of an acre parcel owned by Muskingum County Transportation Improvement District (O.R. 1521, Pg.687 & O.R. 1804, Pg. 509) the following 4 courses and distances:

1-N 21°46'32"E 147.53 feet to a railroad spike found

2-N 28°45'31"E 93.36 feet to a railroad spike found

3-N 33°29'36"E 47.34 feet to a railroad spike found

4-N 83°16'42"E 124.24 feet to an iron pin found on the west line of NORTHPOINTE DRIVE and passing through an iron pin found at **71.30** feet; thence along the west line of said NORTHPOINTE DRIVE (P.B. 19, Pg. 125) the following 4 courses and distances:

1-S 10°58'43"W 317.23 feet to a monument found

2-S 7°50'00"W 350.00 feet to an iron pin set

3-S 8°53'37"E 104.30 feet to an iron pin found

4-S 7°50'04"W 1076.17 feet to a point, said point bears S 80°55'04"E 19.02 feet from an iron pin set; thence on a curve to the left having a radius of 11493.17 feet (the chord of which bears S 6°05'32"W 698.85 feet) an arc distance of 698.96 feet to the true place of beginning containing 23.451 acres.

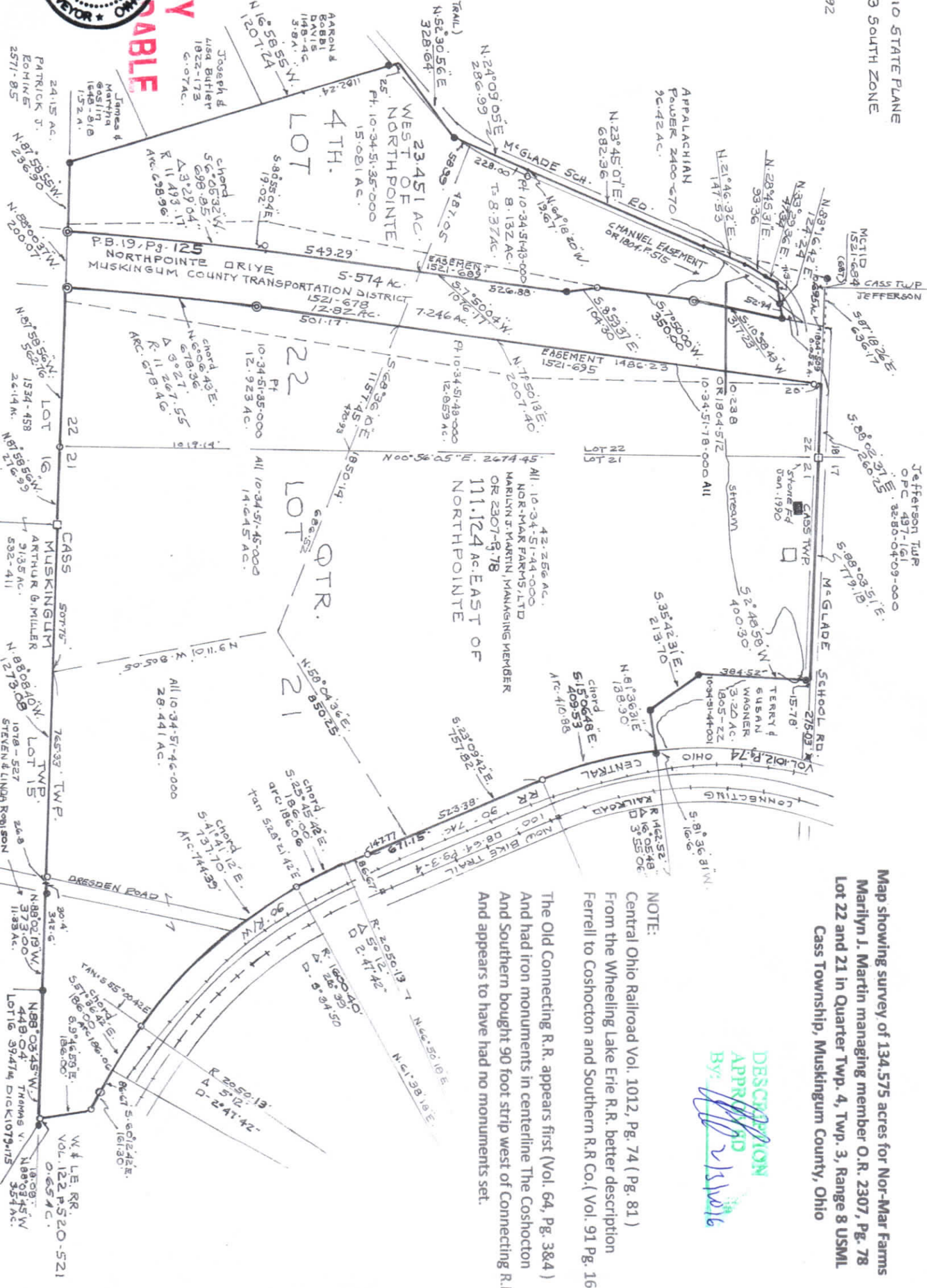
