Being a part of Lot 21 and 22 of Quarter Township 4, Township 3, Range 8 of the United States Military Lands and property owned by NOR-MAR FARMS LTD., Marilyn J. Martin managing member and Recorded in Official Record Book 2307, Page 78 of the Muskingum County Deed Records bounded and described as follows:

Beginning at a stone found January 1990 in the south side of McGlade School Road at the northwest corner of said Lot 21; thence **S 88°03'51"E** ( the base of bearings for this description is The Ohio State Plane Grid System- NAD 83- South Zone ) along the north line of said Lot 21 and along McGlade School Road and along the south line of Ohio Power Property ( Vol. 497, Pg. 161 ) a distance of **779.18** feet to a point; thence along the westerly lines of property owned by Terry and Susan Wagner ( O.R.1805, Pg. 22 ) the following 3 courses and distances:

**1-S 2°48'58"W 400.30** feet to an iron pin found and passing an iron pin found at **15.78** feet

**2-S 35°42'31"E 213.70** feet to an iron pin found

**3-N 81°36'31"E 138.90** feet to a point that bears **S 81°36'31"W 16.60** feet from an iron pin found;

thence along the westerly line of the Ohio Central Railroad Co. ( Vol. 1012, Page 74 ) along a curve to the left having a radius of **1462.52** feet ( the chord of which bears **S 15°06'48"E 409.53** feet ) an arc distance of **410.88** feet to an iron pin set; thence **S 23°09'42"E** along said railroad **757.82** feet to a point and passing an iron pin set at **671.15** feet; thence along said railroad on a curve to the left

having a radius of **2050.13** feet ( the chord of which bears **S 25°45'42"E 186.00** feet) an arc distance of **186.06** feet to an iron pin set; thence along the westerly line of said railroad on a curve to the left having a radius of **1600.40** feet ( the chord of which bears **S 41°41'12"E 737.70** feet ) an arc distance of **744.39** feet to an iron pin set; thence along said railroad on a curve to the left having a radius of **2050.13** feet ( the chord of which bears **S 57°36'42"E 186.00** feet ) an arc distance of **186.06** feet to a point; thence **S 60°12'42"E** along said railroad **161.30** feet to an iron pin set and passing through an iron pin set at **86.67** feet; thence along said railroad on the west line of a 0.65 acre parcel purchased by The Wheeling and Lake Erie Railroad ( Vol. 122, Pg. 520 & 521 ) **S 9°46'58"E 186.00** feet to an iron pin set on the south line of Cass Township, said pin bears **N 88°03'45"W 18.09** feet from an iron pin found;

thence **N 88°03'45"W** along the south line of Cass Township and along the north line of land owned by Thomas V. Dick ( Vol. 1079, Pg. 175 ) in Muskingum Township a distance of **448.04** feet to an iron pin found; thence **N 88°02'19"W** along said township line and the north line of property owned by Steven and Linda Robison ( Vol. 1078, Pg. 527 ) 373.00 feet to a point in the center of Dresden Road and passing through an iron pin found at **342.60** feet; thence **N 88°08'40"W** along said township line and the north line of property owned by Arthur G. Miller ( Vol. 532, Pg. 411 ) a distance of **1273.08** feet to a stone found at the northwest corner of Lot 15 in Muskingum Township; thence **N87°58'56"W** along said township line and the north line of a 26.14 acre parcel of said Arthur G. Miller property ( O.R. 1534, Pg. 458 ) a distance of **276.99** feet to an iron pin set at the southwest corner of Lot 21 in Cass Township; thence **N 87°58'56"W** along said township line and into Lot 22 of said Cass Township and along the north line of said 26.14 acres owned by Arthur G. Miller a distance of **562.76** feet to a monument found on the east right of way of **NORTHPOINTE DRIVE** ( P.B. 19, Pg. 125 ) ); thence along said drive on a curve to the right having a radius of **11267.55** feet ( the chord of which bears **N 6°06'43"E 678.36** feet ) an arc distance of **678.46** feet to a monument found; thence **N7°50'13"E** along said drive **2007.40** feet to a point on the north line of Cass Township and passing through an iron pin set at **1987.40** feet; thence **S 88°02'37"E** along said township line and the south line of said O.P.C. ( Vol. 497, Pg. 161) a distance of **260.25** feet to the place of beginning containing **111.124** acres.

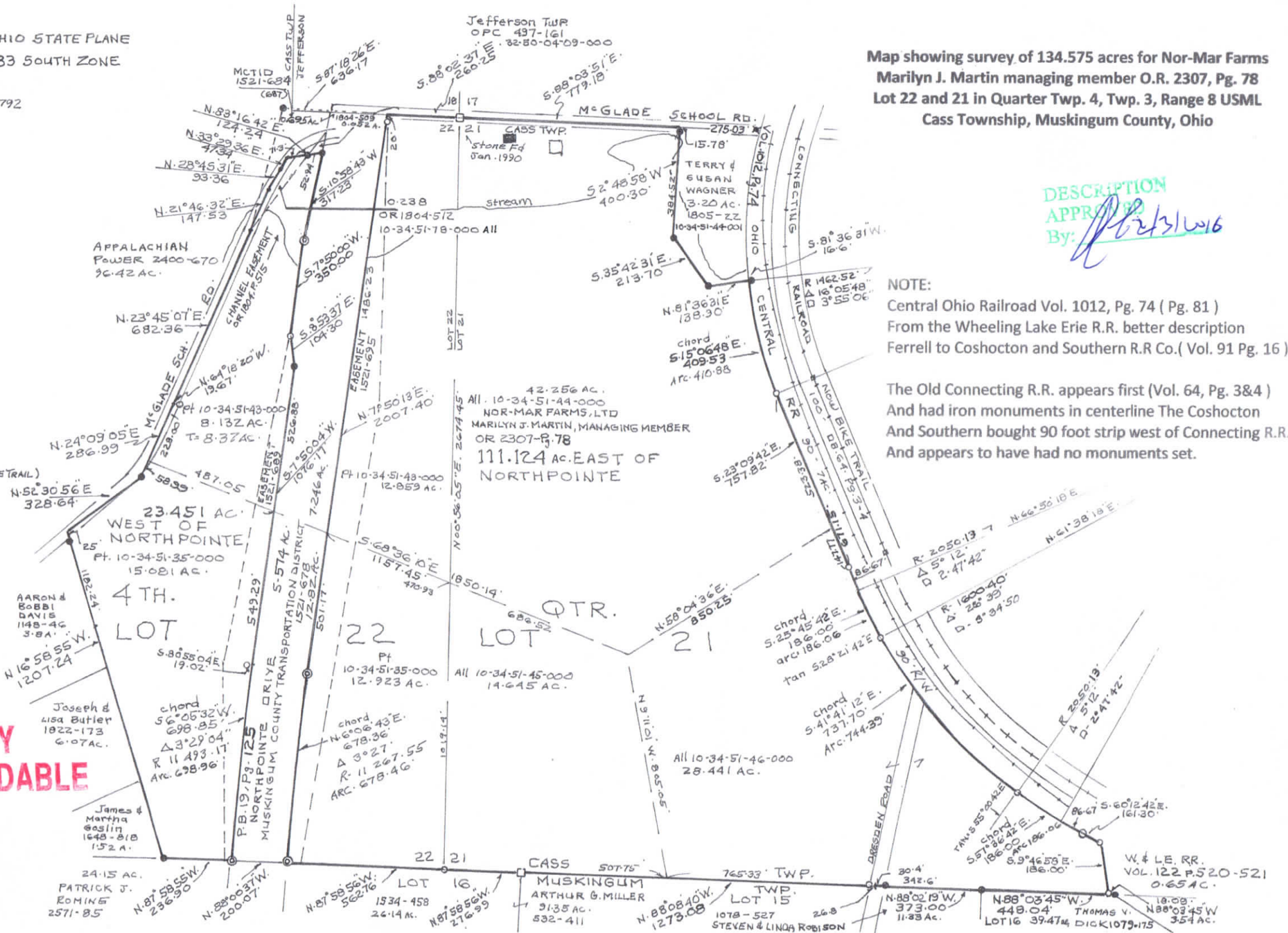
