Township 3, Range 8, United States Military Lands;
thence South 88 degrees 02 minutes 54 seconds East for 12.91 feet to the low water mark of the
Muskingum River;
thence along said low water mark the following two courses:

1) South 25 degrees 14 minutes 00 seconds West for 862.89 feet to a point, from which an
iron pin found bears North 80 degrees 31 minutes 49 seconds West for 20.00 feet;
2) South 07 degrees 26 minutes 13 seconds West for 438.05 feet to the principal place of
