COMMENCING AT THE SOUTHWEST CORNER OF LOT #8 OF BROWN'S ADDITION TO THE VILLAGE OF ROSEVILLE, AS RECORDED IN PLAT BOOK 2, PAGE 120, THENCE, NORTH 90 DEGREES - 00 MINUTES - 00 SECONDS WEST, ALONG THE NORTH LINE OF FIFTH STREET, 12.00 FEET TO AN IRON PIN SET ON THE WEST LINE OF A 12 FOOT ALLEY, AND THE **TRUE POINT OF BEGINNING** FOR THE PARCEL HEREIN DESCRIBED; THENCE, CONTINUING NORTH 90 DEGREES - 00 MINUTES - 00 SECONDS WEST, 164.47 FEET TO AN IRON PIN SET ON THE EAST LINE OF WASHINGTON STREET, PASSING AN IRON PIN FOUND AT 66.00 FEET; THENCE, NORTH 00 DEGREES - 00 MINUTES - 00 SECONDS EAST, 55.42 FEET TO AN IRON PIN SET ON THE SAID EAST LINE, FROM WHICH AN AXLE FOUND BEARS NORTH 17 DEGREES - 57 MINUTES - 14 SECONDS EAST, 56.17 FEET; THENCE, SOUTH 90 DEGREES - 00 MINUTES - 00 SECONDS EAST, 164.47 FEET TO AN IRON PIN SET ON THE WEST LINE OF A 12 FOOT ALLEY, PASSING AN IRON PIN FOUND AT 98.47 FEET; THENCE, SOUTH 00 DEGREES - 00 MINUTES - 00 SECONDS WEST, 55.42 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.2093 ACRES MORE OR LESS.


