Beginning at an iron pin found at the Northeast corner of Lot 53 of the Village of Roseville; Thence North $83^{\circ}13'31''$ East 133.60 feet along the South line of a 12.00 foot wide alley to a point; Thence South $07^{\circ}18'00''$ East along Lot 25 of Jay's Addition to Roseville Plat Book 12, page 44 66.50 feet to an iron pin found; Thence South $83^{\circ}13'31''$ West 209.14 feet to an iron pin set passing the East line of Lot 53 at 134.21 feet; Thence North $06^{\circ}46'29''$ West along Kathy Edgel 66.50 feet to an iron pin found; Thence North $83^{\circ}13'31''$ East along the North line of Lot 53 (South line said 12 foot alley) 74.93 feet to the place of beginning containing 0.318 Acres more or less, 0.114 Acres Parcel 36 and 0.204 Acres Parcel 09.

Commencing at an iron pin found at the Northeast corner of Lot 53 of Village of Roseville; Thence North $06^{\circ}46'29''$ West 12.00 feet to the place of beginning; Thence North $06^{\circ}46'29''$ West along Lot 54 36.35 feet to a point; Thence North $82^{\circ}38'00''$ East along Thornberry Street extended 133.15 feet to an iron pin set passing an iron pin found at 3.74 feet; Thence South $07^{\circ}18'00''$ East along Lot 25 of Jay's Addition to Roseville 37.74 feet to a point on the North line of a 12 foot wide alley; Thence South $83^{\circ}13'31''$ West along said alley 133.48 feet to the place of beginning containing 0.11 Acres more or less.

Beginning at an iron pin set at the Southeast corner of Lot No. 54 of the Village of Roseville; thence North 6° 46' 29" West 36.35 feet; thence North 82° 38' East 133.08 feet along Thornberry Street to an iron pin set passing an iron pin set at 1.08 feet; thence leaving Thornberry Street South 7° 18' East along the West line of Lot No. 25 of Jay's Addition to Roseville 37.75 feet to a 12.00 foot wide alley extended; thence along said alley extended South 83° 13' 31" West 133.41 feet to the place of beginning, containing 0.12 acres more or less.

Parcel Two (contains old Parcels Two & Three)
