MINUTES 15 SECONDS EAST 162.50 FEET (BY DEED) TO A POINT AT THE
NORTHEAST CORNER OF A 2.00 MORE OR LESS ACRE TRACT CONVEYED TO T.
AND C. HOLSKY AS RECORDED IN DEED VOLUME 782, PAGE 213 OF THE
MUSKINGUM COUNTY DEED RECORDS; THENCE SOUTH 04 DEGREES 58 MINUTES
45 SECONDS WEST 252.47 FEET TO A POINT AT THE SOUTHEAST CORNER OF
SAID HOLSKY TRACT; THENCE NORTH 85 DEGREES 01 MINUTES 15 SECONDS
WEST 301.69 FEET TO A POINT IN THE CENTER OF RELOCATED COUNTY ROAD
NUMBER 60 (1967 SURVEY); THENCE ALONG THE CENTER OF SAID COUNTY
ROAD NUMBER 60 THE NEXT (3) COURSES AND DISTANCES:

1) SOUTH 27 DEGREES 45 MINUTES 00 SECONDS EAST 324.95 FEET TO A
POINT,

2) WITH A CURVE TO THE LEFT HAVING A RADIUS OF 2864.79 FEET (CHORD
BEARING SOUTH 31 DEGREES 11 MINUTES 30 SECONDS EAST 343.96 FEET)
AN ARC DISTANCE OF 344.16 FEET TO A POINT,

3) SOUTH 34 DEGREES 38 MINUTES 00 SECONDS EAST 661.77 FEET TO A
POINT; THENCE LEAVING SAID ROAD AND ALONG THE NORTH LINE OF A
2.249 MORE OR LESS ACRE TRACT NORTH 55 DEGREES 22 MINUTES 00
SECONDS EAST 27.03 FEET TO A POINT, SAID POINT BEING THE PLACE OF
BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE
CONTINUING NORTH 55 DEGREES 22 MINUTES 00 SECONDS EAST 195.05 TO
AN EXISTING IRON PIN (3/4 INCH PIPE) AT THE NORTHEAST CORNER OF
SAID 2.249 MORE OR LESS ACRE TRACT, PASSING AN EXISTING IRON PIN
(3/4 INCH PIPE) AT 20.05 FEET; THENCE CONTINUING NORTH 55 DEGREES

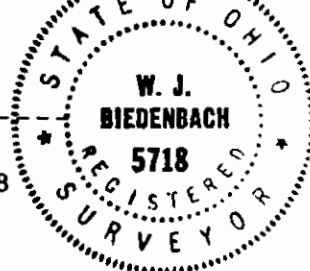

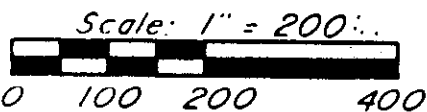
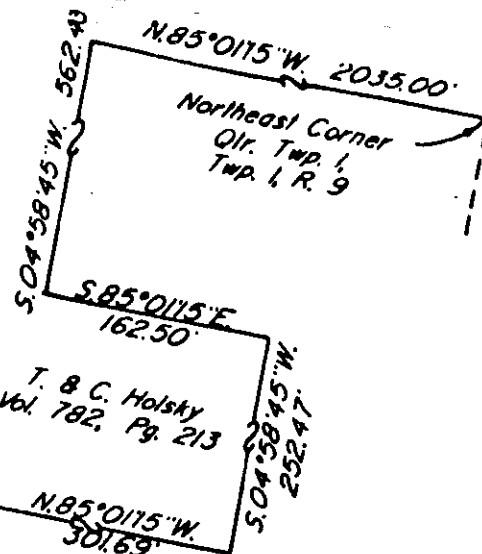
