Situated in the State of Ohio, County of Muskingum, Township of Falls, and being a part of Lot 4 in the Second Quarter of Township-1-North, Range-8-West, United States Military Land and being a part of that 5.12 acre tract (Parcel No. 17-12-02-16-000) as conveyed to Martha L. Holbein, by deed of record in Deed Volume 776, Page 81, all references being to those of record in the Muskingum County Recorder's Office, said 0.891 acre parcel being further described as follows:

Beginning for reference at an existing iron pin marking the Northeast corner of Lot 4 of the John Roberts Survey, recorded in Deed Book 2, Page 366:

thence southwesterly along the easterly line of Lot 4, the same being the East line of Quarter Township 2, **South 06°29'39" West, 504.06 feet** to an existing iron pin (5/8" rebar) marking the southeasterly corner of that 0.98 acre tract as conveyed to Charles A. and Theresa E. Frick, by deed of record in Deed Volume 815, Page 301:

thence continuing southwesterly along said Lot line, **South 06°29'39" West, 635.83 Feet** to a point on the northerly line of that 4.94 acre tract as conveyed to Fred and Christy Little, by deed of record in Deed Volume 886, Page 34, passing an existing iron pin (5/8" rebar "Graham") at **60.16 feet**:

thence northwesterly along the northerly line (existing fence line) of said Little tract and the northerly line of those tracts as conveyed to Gary W. and Diane L. Hamilton, by deed of record in Deed Volume 1142, Page 227, **North 84°39'30" West, 511.20 feet** to an existing iron pin:

thence northwesterly along the original East line of said 5.12 acre Holbein tract, **North 16°29'58" West, 558.78 feet** to an iron pin set, said pin being the southeasterly corner and the **True Point of Beginning** of the hereon described 0.891 acre parcel;

thence southwesterly with what represents a new line through said 5.12 acre Holbein tract, **South 61°29'30" West, 337.01 feet** to an iron pin set on the easterly line of that 5.28 acre tract as conveyed to Ruth A. Goyne, by deed of record in Deed Volume 1074, Page 574;

thence northwesterly along the easterly line of said Goyne tract, **North 11°53'45" West, 121.98 feet** to an iron pin set marking the original northwesterly corner of said 5.12 acre Holbein tract;

thence along the original North line of said 5.12 acre Holbein tract, **North 61°29'30" East, 327.00 feet** to an iron pin set marking the original northeasterly corner of said 5.12 acre Holbein tract;

thence southeasterly along the original East line of said 5.12 acre tract, **South 16°29'58" East, 119.51 feet** to the **True Point of Beginning**, and containing **0.891 acres** more or less according to a survey performed by Graham Surveying in October, 2000.

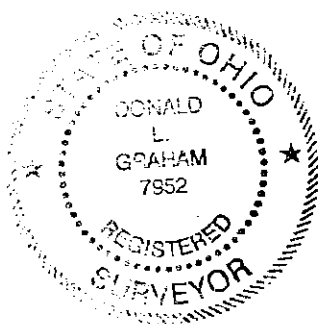
Bearings in the above described **0.891 acre** parcel are based on the centerline of State Route 146 as being **South 63°08'01" East**.
