SITUATED IN THE STATE OF OHIO, COUNTY OF MOSK UM, TOWNSHIP OF FALLS, AND BEING IN QUARTER TOWNSHIP 2, TOWNSHIP IN, RANGE 8W IN THE UNITED STATES MILITARY LANDS, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

AND DORIS M. WILSON, AS RECORDED IN DEED VOLUME 370, PAGE 109, AND BEING ON THE SOUTH LINE OF SAID PARCEL CONVEYED TO HOLBEIN OF WHICH THIS **DESCRIPTION IS A PART;** 

THENCE, S 65°00'00" E 229.80 FEET WITH THE SOUTH LINE OF SAID PARCEL CONVEYED TO HOLBEIN, THE SAME BEING THE NORTH LINE OF SAID PARCEL CONVEYED TO WILSON, TO A NAIL SET IN THE CENTERLINE OF HOLBEIN DRIVE, BEING THE NORTHWEST CORNER OF A 5.64 ACRE PARCEL CONVEYED TO CLARENCE W. AND JUANITA L. HOLBEIN, AS RECORDED IN DEED VOLUME 664, PAGE 296, AND PASSING OVER A NAIL FOUND AT AN ANGLE POINT AT 110.99 FEET;

THENCE, S 87°05'00" E 112.45 FEET WITH THE CENTERLINE OF HOLBEIN DRIVE, THE SAME BEING THE NORTH LINE OF SAID 5.64 ACRE PARCEL CONVEYED TO HOLBEIN, TO A NAIL SET AT AN ANGLE POINT:

THENCE, N 08°42'00" W 513.08 FEET LEAVING SAID CENTERLINE WITH A LINE ACROSS SAID PARCEL CONVEYED TO HOLBEIN OF WHICH THIS DESCRIPTION IS A PART, TO AN IRON PIN SET ON THE SOUTHERLY RIGHT OF WAY LINE OF STATE ROUTE 146, AS RECORDED IN PLAN NO. MUS-146-8.13, AT THE OHIO DEPARTMENT OF TRANSPORTATION DISTRICT 5 OFFICE, BEING THE NORTHWEST CORNER OF THE TRACT HEREIN DESCRIBED, AND PASSING OVER IRON PINS SET AT 20.00 FEET AND 250.00 FEET;

THENCE, S 61°01'23" E 228.63 FEET WITH SAID RIGHT OF WAY LINE OF STATE ROUTE 146, TO AN IRON PIN SET AT AN ANGLE POINT;

THENCE, S 54º10'43" E 259.46 FEET CONTINUING WITH SAID RIGHT OF WAY LINE TO AN IRON PIN SET MARKING THE NORTHEAST CORNER OF A 0.70 ACRE PARCEL CONVEYED TO GREGORY D. AND CHERYL L. SHAFER, AS RECORDED IN DEED VOLUME 842, PAGE 111;

THENCE, S 83°30'00" W 186.19 FEET LEAVING SAID RIGHT OF WAY LINE WITH THE NORTH LINE OF SAID 0.70 ACRE PARCEL CONVEYED TO SHAFER, TO AN IRON PIN FOUND MARKING THE NORTHWEST CORNER THEREOF, AND BEING ON THE EAST LINE OF A 0.76 ACRE PARCEL CONVEYED TO CLARENCE K. AND SHERYL ROSS, AS RECORDED IN DEED VOLUME 787, PAGE 330;

THENCE, N 08°42'00" W 20.00 FEET WITH THE EAST LINE OF SAID 0.76 ACRE PARCEL CONVEYED TO ROSS TO AN IRON PIN FOUND MARKING THE NORTHEAST CORNER THEREOF;

THENCE, S 81°20'38" W 149.95 FEET WITH THE NORTH LINE OF SAID PARCEL CONVEYED TO ROSS TO AN AXLE FOUND MARKING THE NORTHWEST CORNER THEREOF;

THENCE, S 08°42'00" E 219.47 FEET WITH THE EAST LINE OF SAID PARCEL CONVEYED TO ROSS, TO A NAIL SET IN THE CENTERLINE OF HOLBEIN DRIVE, BEING ON THE SOUTH LINE OF SAID PARCEL CONVEYED TO HOLBEIN OF WHICH THIS DESCRIPTION IS A PART, ALSO BEING ON THE NORTH LINE OF SAID 5.64 ACRE PARCEL CONVEYED TO CLARENCE AND JUANITA HOLBEIN, AND PASSING OVER AN AXLE FOUND AT 199.47 FEET;

THENCE, S 82°49'00" W 29.96 FEET WITH THE CENTERLINE OF HOLBEIN DRIVE TO THE PLACE OF BEGINNING, AND CONTAINING 1.4553 ACRES, MORE OR LESS, AND IS SUBJECT TO ALL LEGAL EASEMENTS AND RIGHT OF WAYS OF RECORD.

THENCE, N 61°01'23" W 166.98 FEET WITH SAID RIGHT OF WAY LINE TO AN IRON PIN SET, AND BEING THE NORTHWEST CORNER OF THE EASEMENT HEREIN DESCRIBED;

THENCE, S 05°04'28" W 32.81 FEET;

THENCE, S 61°01'23" E 176.85 FEET TO THE WEST LINE OF THE ABOVE DESCRIBED 1.4553 ACRE PARCEL;

THENCE, N 08°42'00" W 37.91 FEET WITH THE WEST LINE OF SAID 1.4553 ACRE PARCEL, TO THE PLACE OF BEGINNING, AND CONTAINING 5157.3864 SQUARE FEET, MORE OR LESS.

SUBJECT TO A 30 FOOT WIDE EASEMENT FOR INGRESS AND EGRESS AND FOR THE PURPOSES OF INSTALLING AND MAINTAINING A WATER LINE FROM THE CENTERLINE OF HOLBEIN DRIVE, AND FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT A NAIL SET MARKING THE SOUTHWEST CORNER OF SAID 1.4553 ACRE PARCEL AND BEING THE PRINCIPLE PLACE OF BEGINNING OF THE EASEMENT HEREIN TO BE DESCRIBED;

THENCE, N 08°42'00" W 289.16 FEET WITH THE WEST LINE OF SAID 1.4553 ACRE PARCEL, AND PASSING OVER REFERENCE IRON PINS SET AT 20.00 FEET, AND 250.00 FEET;

THENCE, S 58°42'00" E 39.08 FEET WITH A LINE ACROSS SAID 1.4553 ACRE PARCEL;

THENCE, S 08°42'00" E 264.84 FEET TO A NAIL SET IN THE CENTERLINE OF HOLBEIN DRIVE MARKING THE SOUTHEAST CORNER OF SAID 1.4553 ACRE PARCEL, AND PASSING OVER AXLES FOUND AT 45.37 FEET AND 244.84 FEET;

THENCE, S 82°49'00" W 29.95 FEET WITH THE CENTERLINE OF HOLBEIN DRIVE TO THE PLACE OF BEGINNING, AND CONTAINING 8293.52 SQUARE FEET, MORE OR LESS.

Being a part of Quarter Township 2, Township 1, Range 8 bounded and described as follows:
