

Situated in the State of Ohio, County of Muskingum, Township of Falls.

Being a part of Quarter Township 2, Township 1, Range 8 bounded and described as follows:

Commencing at an iron pin on the south right-of-way line of old Newark Road (Old State Rt. #146), located at the corner of lots No. 8 and 9 of Homecroft Acres, as recorded in Plat Book 8, Page 18 of the Muskingum County deed records; thence from said iron pin south 50 degrees 39 minutes east 200 feet to an iron pin at the northeast corner of lot 10 of Homecroft Acres; thence south 65 degrees 00 minutes east for 153.06 feet to a point in the center line of Old Newark Road; thence continuing south 65 degrees 00 minutes east for 76.74 feet to another point in the center line of Old Newark Road; thence south 87 degrees 05 minutes east for 112.45 feet to a point in the center line of Old Newark Road; thence north 82 degrees 49 minutes east for 114.74 feet to a point in the center line of Old Newark Road; thence north 81 degrees 18 minutes east 150 feet to the true place of beginning of the premises herein intended to be conveyed; thence north 8 degrees 42 minutes west 200 feet to an iron pin; thence north 83 degrees 30 minutes east 186.19 feet to an iron pin; thence south 8 degrees 52 minutes west 202.3 feet to a point in the aforesaid Old Newark Road; thence along said road south 81 degrees 18 minutes west 125 feet to the true place of beginning, containing seventy hundredths (0.70) of an acre more or less.


