Commencing at an iron pin on the South right-of-way line of Old Newark Road (Old State Rt. #146), located at the corner of Lots 8 and 9 of Homecroft Acres, as recorded in Plat Book 8, Page 18, of the Muskingum County Deed Records; thence from said iron pin South 50 degrees 39 minutes East 200 feet to an iron pin at the northeast corner of Lot 10 of Homecroft Acres; thence South 65 degrees 00 minutes East for 153.06 feet to a point in the center line of Old Newark Road; thence continuing South 65 degrees 00 minutes East for 76.74 feet to a point in the center line of Old Newark Road; thence south 87 degrees $0\overline{5}$ minutes east for 112.45 feet to a point in the center line of Old Newark Road; thence north 82 degrees 49 minutes east for 114.74 feet to a point in the center line of Old Newark Road; thence north 81 degrees 18 minutes east 275 feet to the true place of beginning for the premises herein intended to be conveyed; thence leaving the center of Old State Route #146 north 8 degrees 52 minutes East 202.30 feet to an iron pin on the South right of way line of New State Route #146 (1962 survey); thence North 26 degrees 52 minutes East 130 feet to a point in the center of said new State Route #146; thence along the center of said road South 63 degrees 08 minutes East 110.84 feet to a point; thence leaving said road South 26 degrees 52 minutes West 115.16 feet to an iron pin on the South right-of-way line of State Route #146; thence South 8 degrees 52 minutes West 151.36 feet to a point in the center of Holbein Drive (Old State Route #146); thence along said Drive south 87 degrees 38 minutes west 39.10 feet to a point; thence South 81 degrees 13 minutes West 75.15 feet to the true place of beginning, containing seventy-six hundredths (0.76) of an acre more or less, of which there is 0.31 acre in the right of-way of State Route #146.
