in Quarter Township 1, Township 1, Range 8 bounded and described as follows:

Beginning at an iron pin found that is 60 feet left of Station 17+40 on a centerline survey of the  
proposed Zanesville Industrial Park Road recorded in Plat Book 15, Page 73; thence north 87 degrees  
19 minutes 52 seconds west 300 feet to an iron pin; thence north 2 degrees 40 minutes 08 seconds  
east 282 feet to an iron pin; thence south 87 degrees 19 minutes 52 seconds east 320 feet to an iron  
pin on the west right of way line of the aforesaid road; thence along said right of way line the  
following three (3) courses and distances, south 2 degrees 40 minutes 08 seconds west 22 feet to an  
iron pin; thence south 8 degrees 22 minutes 46 seconds west 201 feet to an iron pin; thence south 2  
degrees 40 minutes 08 seconds west 60 feet to the place of beginning, containing two (2) acres more  
or less.

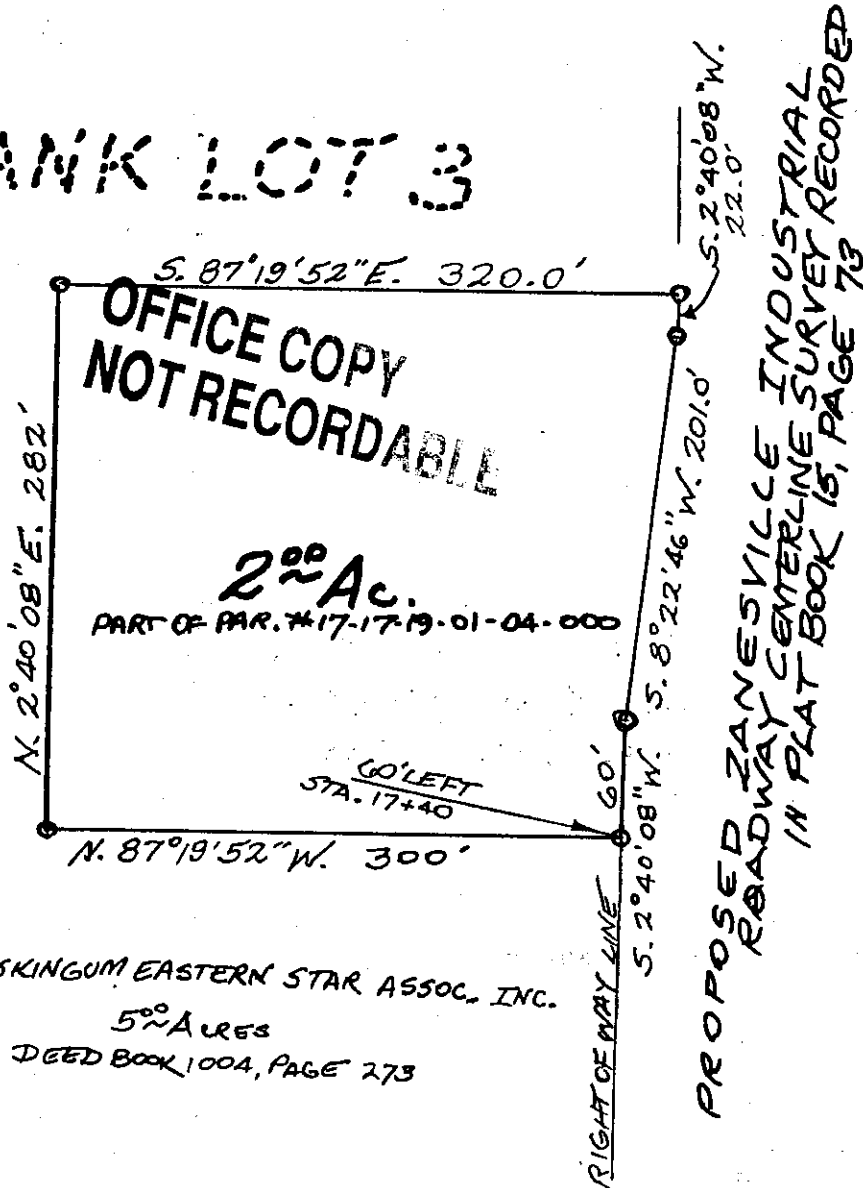

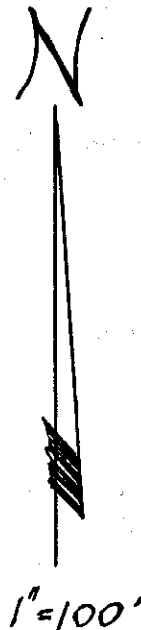
