

Beginning at the northeast corner of Bank lot 9 and recorded in deed book K, page 644 of the deed records of said county; thence south 00 degrees 19 minutes 30 seconds east along the easterly line of said lot a distance of 1176.44 feet to an iron pin; thence north 71 degrees 31 minutes 43 seconds west along the northerly line of a 27.406 acre parcel a distance of 1479.61 feet to a point in Old Falls Road and passing through an iron pin at 1449.61 feet; thence north 25 degrees 34 minutes 50 seconds east along said road a distance of 135.60 feet to a point; thence north 26 degrees 38 minutes 00 seconds east along said road a distance of 645.39 feet to a point; thence on a curve to the right having a radius of 573.69 feet (the chord of which bears north 27 degrees 02 minutes 56 seconds east a chord distance of 8.31 feet) an arc distance of 8.31 feet to a point; thence north 89 degrees 56 minutes 40 seconds east along the southefly line of Shady lane acres and recorded in plat book 9, page 12 of the plat records of said county a distance of 1045.07 feet to the true place of beginning and passing through an existing iron pin at 22.25 feet, containing 27.406 acres more or less.
