AUDITOR PARCEL  
91-17-19-03-26-000 (PART 0.630 Acres)

Situated in Bank Lot 9, Quarter Township1, T-1-N, R-8-E, S.3-M.L., City of Zanesville, Muskingum County, Ohio. Being part of the lands of Kent and Connie McWherther, last conveyed in deed book 941 page 103 of the Muskingum County Deed Records and being described as follows:

Beginning at a set rebar marking the Northeast corner of Lot 15 of Pine Ridge Subdivision as recorded in the Muskingum County Plat Records:

Thence, **S.71°25'11"E.** a distance of **33.20** feet along the South line of the lands of C. Sharp (941/092) to a set rebar;

Thence, **S.07°35'19"E.** a distance of **244.63** feet through the lands of K. McWherter (941/092) to a set rebar on the North line of a 50 foot wide Right of Way;

Thence, **S.82°24'41"W.** a distance of **151.96** feet through said McWherter lands and along said right of way to a set rebar on the Southeast corner of lot 9 of Pine Ridge Subdivision;

Thence, **N.08°10'11"E.** a distance of **173.97** feet along said lot to a point on the rim of a manhole, being the common corner to lots 9,14, and 15 of aforesaid subdivision;

Thence, **N.31°37'06"E.** a distance of **118.52** feet along lot 15 to the point of beginning.

The above described parcel contains 0.630 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

Also attached to the above described parcel is a 50 foot wide right of way for the purpose of ingress and egress to Colburn Drive being described as follows:

Beginning at the Northeast corner of lot #8 of Pine Ridge Subdivision;

Thence, on a curve to the right an arc distance of 60.81 feet, with a radius of 100.00 feet, whose chord bears, **S.46°21'14"E.** a distance of **59.88** feet to a set rebar;

Thence, on a curve to the left an arc distance of 121.99 feet, with a radius of 325.00 feet, whose chord bears, **S.39°41'08"E.** a distance of **121.28** feet to a set rebar;

Thence, on a curve to the left an arc distance of 119.10 feet, with a radius of 325.00 feet, whose chord bears, **S.60°56'16"E.** a distance of **118.44** feet to a set rebar;

Thence, on a curve to the left an arc distance of 168.15 feet, with a radius of 325.00 feet, whose chord bears, **S.86°15'31"E.** a distance of **166.28** feet to a set rebar;

Thence, **N.11°05'03"W.** a distance of **50.00** feet to a set rebar;

Thence, on a curve to the right an arc distance of 360.16 feet, with a radius of 275.00 feet, whose chord bears, **N.63°33'42"W.** a distance of **334.97** feet to a set rebar;

Thence, on a curve to the right an arc distance of 92.04 feet, with a radius of 50.00 feet, whose chord bears, **N.29°40'42"E.** a distance of **79.58** feet to a set rebar;

Thence, **N.82°24'41"E.** a distance of **211.03** feet to a set rebar;

Thence, **N.07°35'21"W.** a distance of **50.00** feet to a set rebar;

Thence, **S.82°24'41"W.** a distance of **242.96** feet to a set rebar on the Southeast corner of lot 9 of Pine Ridge Subdivision;

Thence, **S.36°44'07"W.** a distance of **136.82** feet along the East end of Colburn Drive to the point of beginning.

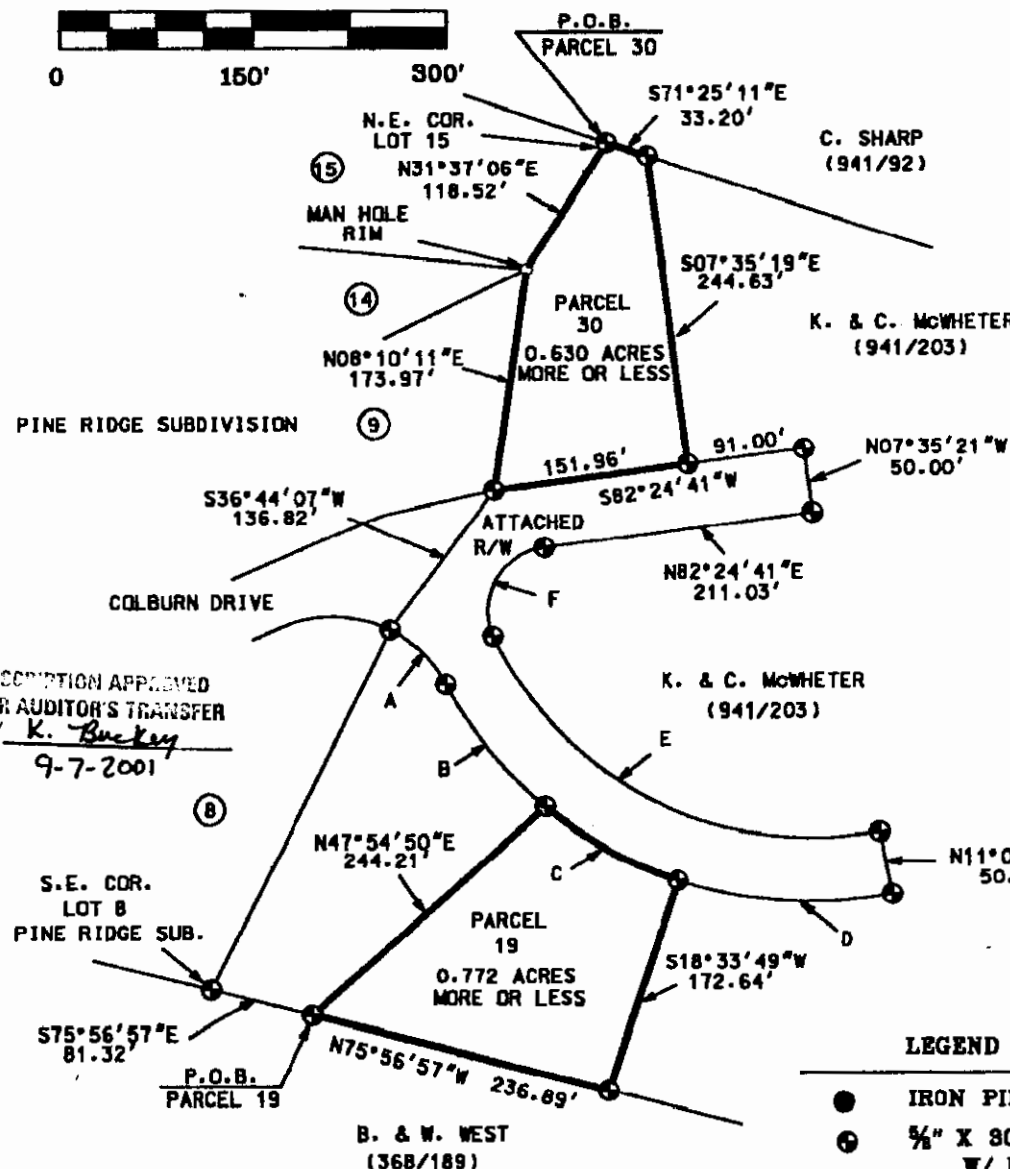
