thence; along the east line of Eagle Crest, Ltd, Deed Book 1869, Page 732, North 00 degrees 16 minutes 14 seconds East 83.72 feet to an iron pin found,

thence; along the east line of Martha Joyce Siler, Deed Book 570, Page 938, North 00 degrees 11 minutes 35 seconds East 233.44 feet to the true point of beginning containing four and fifty-nine hundredths (4.59) acres more or less, with five hundredths (0.05) of an acre being within the Hale Road right of way, leaving four and fifty-four hundredths (4.54) acres.
