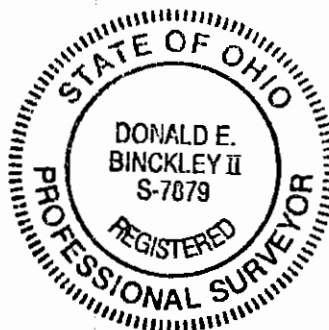

This description is based on an actual survey completed by Binckley Land Surveying in September, 2003.

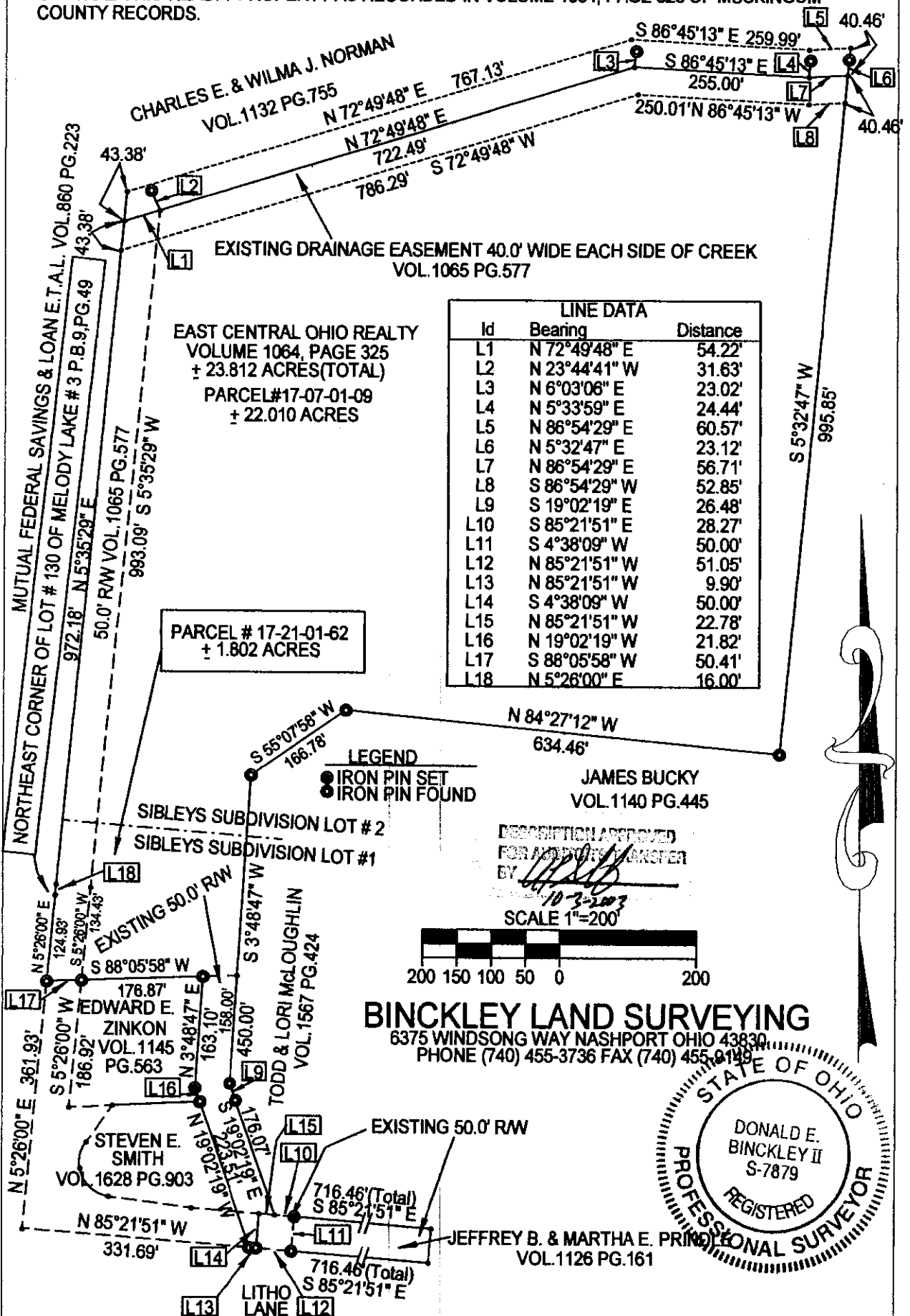

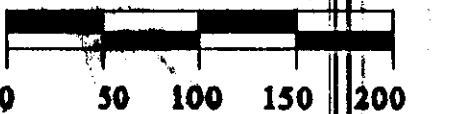

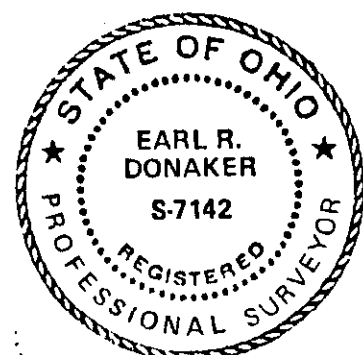
