BEGINNING AT AN IRON PIPE FOUND AT THE SOUTHEAST CORNER OF SAID LOT #3, THENCE, NORTH 84 DEGREES - 29 MINUTES - 30 SECONDS WEST, 175.00 FEET ALONG THE SOUTH LINE THEREOF AND THE NORTH LINE OF LOT #7 OF GREENBRIAR ESTATES #2, AS RECORDED IN PLAT BOOK 15, PAGE 143, TO A POINT AT THE SOUTHWEST CORNER OF LOT #3 ON THE EAST LINE OF GREENBRIAR DRIVE (TOWNSHIP ROAD 1707); THENCE, ALONG THE EAST LINE THEREOF, NORTH 05 DEGREES - 45 MINUTES - 00 SECONDS EAST, 59.90 FEET TO AN IRON PIN SET; THENCE, LEAVING SAID ROAD, SOUTH 84 DEGREES - 29 MINUTES - 32 SECONDS EAST, 175.00 FEET TO AN IRON PIN SET ON THE EAST LINE OF AFORESAID LOT #3; THENCE, SOUTH 05 DEGREES - 45 MINUTES - 00 SECONDS WEST, 59.90 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.2406 ACRES MORE OR LESS.

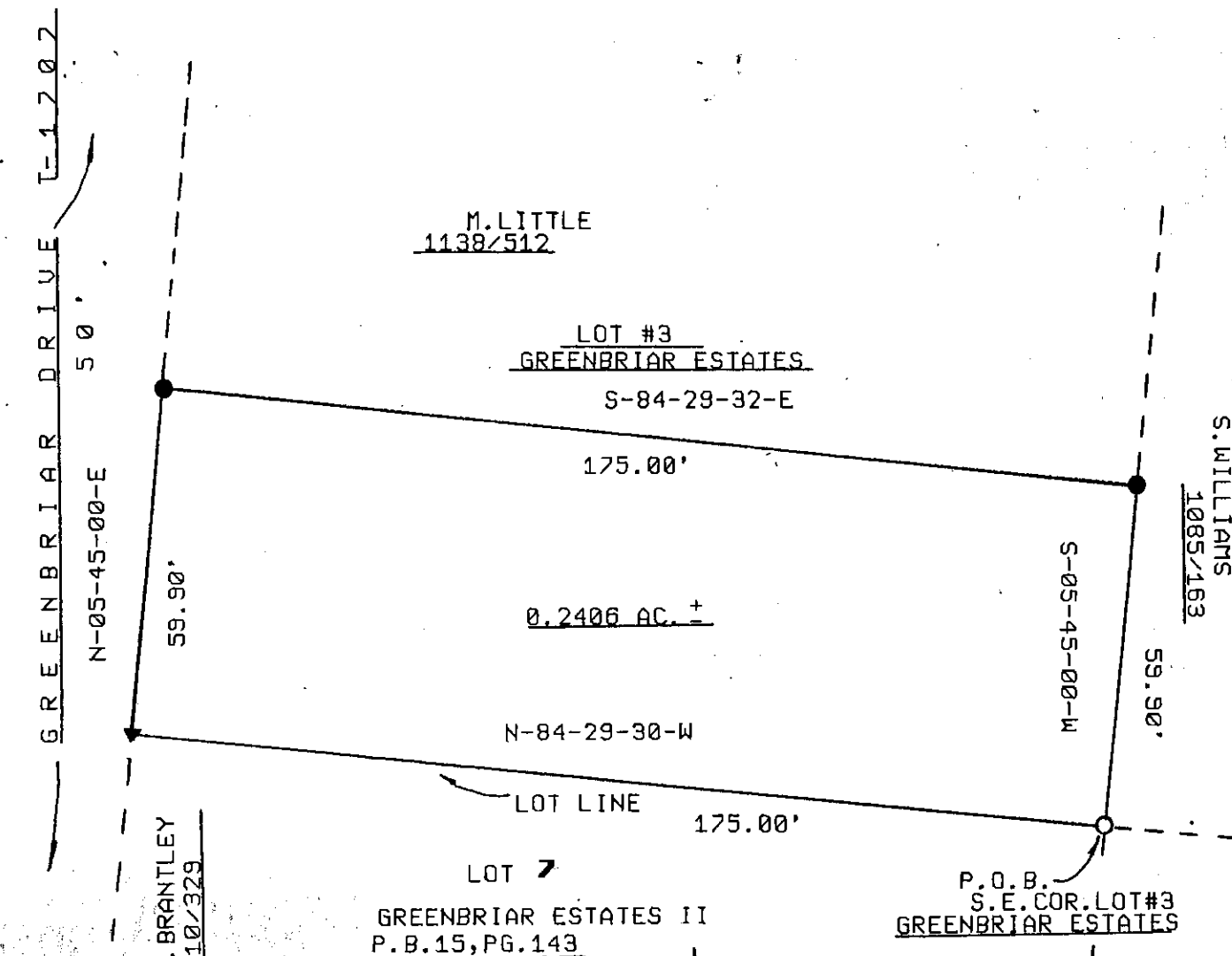
