

Rissing and Jo Ellen Rissing by deed recorded in Deed Book 997, Page 217; thence along the south line of said 1.23 acre parcel north 69 degrees 00 minutes 48 seconds east 219.11 feet to an iron pin; thence south 84 degrees 24 minutes 32 seconds east 87.45 feet to an iron pin; thence north 19 degrees 56 minutes 21 seconds east 107.58 feet to an iron pin on the culdesac at the end of Penny Lane as recorded in Plat Book 17, Page 84; thence along said culdesac on a curve to the left having a radius of 50.0 feet an arc length of 52.36 feet (the chord of which bears south 70 degrees 03 minutes 39 seconds east 50.0 feet) to an iron pin; thence south 19 degrees 56 minutes 21 seconds west 114.79 feet to an iron pin; thence south 80 degrees 15 minutes 06 seconds east 215.52 feet to an iron pin; thence south 5 degrees 35 minutes 28 seconds west 554.78 feet to the place of beginning, containing four and twenty-one hundredths (4.21) acres more or less.
